The purpose is to perform wildlife and vegetation monitoring within and adjacent to the Jemez Canyon Reservoir flood control pool in relation to drawdown of the reservoir. In 2003, the U.S. Fish and Wildlife Services issued a Biological Opinion for the Silvery Minnow. Item C of this opinion required the Corps of Engineers, in coordination with Santa Ana Pueblo, to identify alternatives that will improve the mobilization of sediment from Jemez Reservoir to the Rio Grande. Wildlife and Vegetation Monitoring is

part of compliance with the Biological Opinion. The benefit of this project is that it will establish future wildlife stewardship as well as an ecological database for the Pueblo of Santa Ana. This project will employ 20 employees.
