## 2011 Statewide Watercraft Inspection & Decontamination Sites

All sites listed are issuing and accepting green seals from other state-authorized inspection locations. Seals will be issued upon the completion of inspections or decontaminations upon exiting reservoirs, DOW offices and private service providers. A green seal will expedite the inspection process greatly but boaters with seals still have to stop at the inspection station and have the seal verified by an inspector prior to launching. Remember to request your green seal when leaving your favorite lake or reservoir to ensure a quicker launch next time you boat!

# Lakes and reservoirs where mussels have been detected (mandatory inspections of all trailered watercraft both entering and exiting):

### Blue Mesa Reservoir (Gunnison County)

Boat inspections begin in the spring when the ice melts at Lake Fork and Elk Creek boat ramps. April hours are from 6:30am-4pm, 7 days a week. May 1-May 20 Elk Creek, Lake Fork and Iola Boat Ramps and Inspection Stations are open from 6 a.m. – 8:30p.m, 7 days a week. May 21-through the summer Elk Creek, Lake Fork, Iola and Stevens Creek Boat Ramps and Inspection Stations are open from 5:30am-9pm, 7 days a week. Hours will change late summer and into the fall with the sunrise/sunset schedule. Iola and Stevens Creek boat ramps will close as recreational use diminishes sometime in the late summer or early fall. All other boat ramps will be closed to trailered and motorized watercraft. Ramps will be closed to nighttime use; however, overnight beaching will be allowed.

## **Lake Granby (Grand County)**

Boat inspections begin May 13 at the Sunset Point and Stillwater boat ramps from 6 a.m.-8 p.m., 7 days a week. Arapahoe Bay Ramp will have inspections in place on Friday, Saturday and Sunday only. All other times boaters using Arapahoe Bay are expected to get their inspection at the Stillwater Boat Ramp. All ramps will be open to nighttime use. Boaters are expected to follow the Clean, Drain and Dry protocol when inspectors are not present and must have their watercraft inspected at a state-certified site before launching at a new location.

#### **Grand Lake (Grand County)**

Boat inspections begin May 13 at the Grand Lake public boat ramp from 6 a.m. - 8 p.m., 7 days a week. Ramps will be open to nighttime use. Boaters are expected to follow the Clean, Drain and Dry protocol when inspectors are not present and must have their watercraft inspected at a state certified site before launching at a new location.

## Jumbo Reservoir State Wildlife Area (Logan County)

Boat inspections begin March 11 at the east boat ramp (near the outlet tower) from 9 a.m. - 7 p.m., Friday, Saturday, Sunday and Monday (Closed Tuesday through Thursday). All other ramps will only be open to hand-launched boats. All boat ramps will be closed at night. As of April 1<sup>st</sup> the reservoir will be open 7 days a week from 7 a.m. - 8 p.m. From May 1 – September 15, the reservoir will be open 7 days a week from 6 a.m. - 8 p.m. The reservoir will be closed September 16-September 30, 2011. From October 1 to the last day of regular goose season, inspection will be by appointment only for permitted waterfowl hunters.

## **Lake Pueblo State Park (Pueblo County)**

The park is open to boating year round, but is dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Fall/Winter/Spring boat inspection hours (from October 15-April 14) are 5am to 6pm. Summer inspection hours (from April 15-October 14) are 5am to 11pm. Outside of inspection hours, boat ramps are closed but boats may moor overnight.

### **Shadow Mountain Reservoir (Grand County)**

Boat inspections begin May 13 at the Green Ridge boat ramp from 6 a.m. - 8 p.m., 7 days a week. The Hilltop boat ramp will be closed to trailered watercraft for the entire 2011 season. The Green Ridge Ramp will be open to nighttime use. Boaters are expected to follow the Clean, Drain and Dry protocol when inspectors are not present and must have their watercraft inspected at a state-certified site before launching at a new location.

## **Tarryall Reservoir State Wildlife Area (Park County)**

Boat inspection begin May 1 at the north boat ramp from 6 A.M. -10 P.M. Thursdays through Mondays and will continue till Oct  $31_{st}$ . Overnight beaching of boats is prohibited.

## Willow Creek Reservoir (Grand County)

Willow Creek reservoir will be closed to trailered, motorized watercraft for the entire 2011 season. Only hand-launched, regulation exempted, non-motorized boats are permitted.

# Lakes and reservoirs where no mussels have been detected (inspections required of all trailered watercraft prior to entering):

#### **Antero Reservoir (Park County)**

Boat inspections begin May 1 at the North and South boat ramps. The South Boat Ramp is open seven days a week from ½ hour before sunrise to ½ hour after sunset. The North Boat Ramp is only open Friday through Monday from ½ hour before sunrise to ½ hour after sunset and is closed Tuesday through Thursday. Both ramps close for the season on Oct 31st. Overnight beaching of boats is prohibited.

## **Aurora Reservoir (Arapahoe County)**

Mandatory boat inspections are currently in effect. Boat operators at this reservoir will pay a one-time fee of \$10 to obtain a Watercraft Access Pass for every vehicle towing or otherwise transporting any boat or watercraft to the reservoirs. Watercraft Access Pass is valid at both Aurora & Quincy Reservoirs. Hours of operation vary by month: Boating Season is March 15<sup>th</sup> through November 30<sup>th</sup>, depending on ice conditions. March hours are 6:30am – 8pm, April hours are 6am – 8:30pm, May hours are 5:30 a.m. – 9 p.m., June and July hours are 5:00 a.m. – 9:30 p.m., August hours are 5:30 a.m. – 9:00 p.m., September hours are 6:00 a.m. – 8:00 p.m., October hours are 6:30 a.m. – 7:30 p.m., and November hours are 6:30 a.m. – 6:00 p.m. All watercraft are required to be off the water one-half hour after sunset. The reservoir will be closed

to boating December 1<sup>st</sup>. (Closure may be earlier if ice starts to form). Visit www.auroragov.org for further information. Aurora does not accept any seals from other agencies.

## **Barr Lake State Park (Adams County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 1- Labor Day weekend) are 7am to 3pm Monday-Thursday, and 7am to 7pm Friday-Sunday. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November 1-February 28/29.

## **Bear Creek Lake (Jefferson County)**

Boat inspections begin March 15 from 6 a.m. – 8 p.m., 7 days a week. The inspection station, located at the Whitetail parking lot on the road to the Bear Creek boat ramp, will be staffed from 6 a.m. – 8 p.m., Friday through Sunday. Monday through Thursday the station will be staffed from 6 a.m. – 10 a.m. and 4 p.m. – 8 p.m. Between 10 a.m. and 4 p.m. Monday through Thursday, boaters will be inspected at the entrance station. No watercraft will be allowed access after 8 p.m. Bear Creek will be closed to trailered watercraft from November 15 – March 15 annually.

## **Boulder Reservoir (Boulder County)**

Boat inspections are available year round. Hours of operation vary by month: March hours are 9 a.m. – 4 p.m. April hours are 9 a.m. – 5 p.m. May 1-16 hours are 8 a.m. – 6 p.m. May 17-21 hours are 6 a.m. – -6 p.m. May 22-28 hours are 6 a.m. – 7 p.m. May 29-September 6 hours are 5:30 a.m. – 8 p.m. September 6-30 hours are 7 a.m. – 6 p.m. October hours are 8 a.m. – 5 p.m. November hours are 9 a.m. – 4 p.m. December 2011 to February 2012 hours are 9 a.m. – 3 p.m. Inspections will be offered in the field to the NE of the front gate. In order to launch you must have a City of Boulder green seal with receipt. To receive a green seal you cannot be coming from an infested body of water and you must pass a thorough high risk inspection. The cost for a high risk inspection is \$35. If coming from an infested body of water or you fail the high risk inspection then it is required that you either get decontaminated or sit through the quarantine time prior to launching. Also, boaters must have a current City of Boulder Reservoir Permit to enter. No day use passes will be issued.

### **Boyd Lake State Park (Larimer County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from March 1-April 30) are 6am to 6pm at the main boat ramp only. Summer inspection hours (from May 1-September 30) are 6am to 10pm. Fall inspection hours (from October 1-November 30) are 6am to 6pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from December 1-February 28/29.

## **Carter Reservoir (Larimer County)**

Boat inspections begin April 1 at all three ramps from 6 a.m. -10 p.m. All ramps will be closed to nighttime use. Beginning in October, the ramps will be open from 7 a.m. -5 p.m.

## **Chatfield Reservoir State Park (Jefferson and Douglas Counties)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from March 1-April 30) are 6am to 6pm at the North and South boat ramps. Summer inspection hours (from May 1-September 30) are 6am to 10pm. Fall inspection hours (from October 1-November 30) are 6am to 6pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from December 1-February 28/29.

### **Cherry Creek Reservoir State Park (Arapaho County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from March 1-April 30) are 6 am to 6 pm. Summer inspection hours (from May 1-September 30) are 6am to 10pm at the East and West boat ramps. Fall inspection hours (from October 1-November 30) are 6am to 6pm daily at the East ramp, and 6am to 6pm Friday-Sunday at the West ramp. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from December 1-February 28/29.

## **Clear Creek Reservoir (Chaffee County)**

Boat inspections begin May 5. From May 6 through May 22, the boat ramp will be open Thursday through Sunday from 7 a.m. -5 p.m. From May 26 through September 5, the boat ramp will be open Thursday through Monday from 6 a.m. -9 p.m. From September 8 through September 25, the boat ramp will be open Thursday through Sunday from 7 a.m. -5 p.m. The boat ramp will close for the season on September 26, 2011. All ramps will be closed when inspections are not in place during the week and at night. Overnight beaching of boats is prohibited.

#### **Crawford Reservoir State Park (Delta County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 6am to 8pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from October 16-March 31.

#### **Douglas Reservoir State Wildlife Area (Larimer County)**

Boat inspections begin April 1 from 6 a.m. - 10 p.m., 7 days a week. All ramps will be closed at night. Overnight beaching of boats is prohibited.

## **Dillon Reservoir (Summit County)**

Boat inspections begin May 27 (or sooner weather pending) at the Dillon Marina, from 9:00 a.m. – 5:30 p.m. Weather and water levels permitting. After September 5th call Dillon Marina for fall hours or check web site. The boat ramp will be closed for nighttime use beginning at 5:30 p.m. Boat inspections begin May 27 at the Frisco Bay Marina, from 9 a.m. - 7 p.m., 7 days a week. The Pine Cove and Blue River Arm boat ramps will be closed for the entire 2011 season. Boats will not be allowed to launch after 7 p.m. and all ramps will be closed to nighttime use.

## **Eleven Mile Reservoir State Park (Park County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Entire boating season inspection hours, from April 1 or April 15 (ice dependent) -November 30, are 1/2 hour before sunrise to 1/2 hour after sunset at either open ramp. Outside of inspection hours, lake is closed to boating. The park is closed to trailered watercraft from December 1-March 31.

## **Elkhead Reservoir State Park (Routt County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 6am to 1/2 hour after sunset. Outside of inspection hours, lake is closed to boating. The park is closed to trailered watercraft from November 1-April 30.

#### **Green Mountain Reservoir (Summit County)**

Boat inspections began May 27 and will continue through September (weather pending) at both the McDonald Flats and Heeney Marina ramps. Inspections are available from 6:00 a.m. -9:00 p.m., 7 days a week. Boats will not be allowed to launch after 9:00 p.m. and all ramps are closed to nighttime use. Overnight beaching is allowed for campers staying onsite overnight. For more information, contact the Heeney Marina.

#### Harvey Gap Reservoir State Park (Garfield County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from April 1-May 14) are 8am to 4pm Saturday-Sunday. Summer inspection hours (from May 15-September 14) are 7am to 7pm Monday-Friday, and 7am to 9pm Saturday-Sunday. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November 1-March 31.

## **Highline Reservoir State Park (Mesa County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information.

Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 7am to 7:30pm Monday-Friday, and 7am to 8pm Saturday-Sunday. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November 1-February 28/29.

## **Horsetooth Reservoir (Larimer County)**

Boat inspections began April 1 at all three ramps from 6 a.m. -10 p.m. All ramps will be closed to nighttime use. Beginning in October, the ramps will be open from 7 a.m. -5 p.m. Horsetooth is open to boating year round.

## **Jackson Lake State Park (Morgan County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from March 1-April 30) are 9am to 5pm Monday-Friday, and 8am to 6pm Saturday-Sunday. Summer inspection hours (from May 1-September 30) are 7am to 8pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from December 1-February 28/29.

## John Martin Reservoir State Park (Bent County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Spring boat inspection hours (from March 15-May 14) are 6am to 8pm Friday-Sunday, and 8am to 4pm Monday-Thursday. Summer inspection hours (from May 15-September 14) are 6am to 10pm. Fall inspection hours (from September 15-October 31) are 8am to 4pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November 1-March 14.

#### **Lathrop State Park (Huerfano County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Entire boating season inspection hours (from April 1-October 31) are sunrise to sunset. Outside of inspection hours, the lake is closed to boating. The park is closed to trailered watercraft from November 1-March 31.

## **Mancos State Park (Montezuma County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 8am to 8pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from October 16-March 31.

### McPhee Reservoir (Montezuma County)

Boat inspections will begin May 2 at the main boat ramp from 7:00 a.m. -7:00 p.m. and will continue through October. House Creek Boat Ramp will be open for inspections Thursday through Sunday from 7:00 a.m. -5:00 p.m. This station will also service out-of-state boats coming in from the southwest.

## Navajo Reservoir State Park (La Plata County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from December 1-February 28/29 depending on lake ice conditions.

## **North Sterling Reservoir State Park (Logan County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Boats may be launched from Elks Boat Ramp at the north end of the park. From May 21st to May 27th, inspectors will be onduty from 8am to 8pm Friday through Sunday, and 8am-4pm Monday through Thursday. From May 28th to May 31st, inspectors will be on-duty from 7am to 8pm. Due to construction, the South Boat Ramp may not be accessible for Memorial Day Weekend - boaters may need to use Elks Boat Ramp instead. Parking will be limited. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from October 1-April 14.

#### Paonia Reservoir State Park (Delta County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from September 1-April 30.

#### **Pearl Lake State Park (Routt County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Pearl Lake does not have an inspection station currently, but all trailered watercraft must be inspected prior to launch. Inspections can be done at any State Park inspection location with subsequent seal and receipt being dropped off in seal drop box within Park Lake prior to launch. Spring boating season is from May 1-May14. Summer boating season is from May 15-September 14, and fall boating season is from September 15-October 15. The park is closed to trailered watercraft from October 16-April 30.

#### **Prewitt Reservoir (Washington County)**

Boat inspections begin March 11 at the main boat ramp from 9 a.m. - 7 p.m., Friday, Saturday, Sunday and Monday (Closed Tuesday through Thursday). All other areas will only be open to

hand-launched boats. All boat ramps will be closed at night. As of April  $1^{st}$  the reservoir will be open 7 days a week from 7 a.m. -8 p.m. From May 1 – September 15, the reservoir will be open 7 days a week from 6 a.m. -8 p.m. The reservoir will be closed for the boating season on September 16, 2011.

## **Quincy Reservoir (Arapahoe County)**

Boat inspections begin on March 1, depending on ice conditions. Boat operators at this reservoir will pay a one-time fee of \$10 to obtain a Watercraft Access Pass for every vehicle towing or otherwise transporting any boat or watercraft to the reservoirs. Watercraft Access Pass is valid at both Aurora & Quincy Reservoirs. Quincy Reservoir is open from March 1<sup>st</sup> through October 31<sup>st</sup>. Hours of operation vary by month: March hours are 6:30am to 8pm, April hours 6am to 8:30pmMay hours are 5:30 a.m. – 9:00 p.m., June and July hours are 5:00 a.m. – 9:30 p.m., August hours are 5:30 a.m. – 9:00 p.m., September hours are 6:00 a.m. – 8:00 p.m., October hours are 6:30 a.m. — 7:30 p.m. All watercraft are required to be off the water one-half hour after sunset. Quincy Reservoir closes for the season on October 31. Visit www.auroragov.org for further information. Quincy does not accept any seals from other agencies.

## Rampart Reservoir (El Paso County)

Boat inspections estimated to begin May 14 (but may depend on weather), from 7 a.m.-5 p.m., Thursday through Sunday. All ramps are closed Monday through Wednesday and at night. Overnight beaching of boats is prohibited. The reservoir will close to trailered watercraft mid-October.

## Ridgway Reservoir State Park (Ouray County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 7am to 8pm Monday-Thursday, 7am to 10pm Friday-Saturday, and 7am to 8pm Sunday. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November-February 28/29.

#### Rifle Gap Reservoir State Park (Garfield County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Summer inspection hours (from May 15-September 14) are 7am to 9pm. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from November 1-March 31.

#### **Ruedi Reservoir (Pitkin County)**

Boat inspections and decontaminations begin May 27<sup>th</sup> at the Main Ramp and will be in operation on weekends through September 5<sup>th</sup>. Hours of operation will be 12 noon - 7 PM on Fridays, 8 AM - 8 PM on Saturdays and 8 AM - 2 PM on Sundays. On holiday weekends such as July 4 and Labor Day, Sunday hours will be extended to 8 PM and Monday hours will be 8

AM - 2 PM. The inspection station is located at the base of the campground/boat ramp entry road at Ruedi Creek. The boat ramp will be open for use on weekdays and after hours on weekends and boaters are required to have valid green seal and receipt from another certified state location prior to launch.

## Sanchez Reservoir State Wildlife Area (Costilla County)

Boat inspections begin on May 1 from 6 a.m. – 8 p.m. Inspection station hours may vary throughout the summer however the station will be open roughly from 30 minutes before sunrise to 30 minutes after sunset. It is mandatory that all trailered watercraft launch from the boat ramp when inspectors are present and no shoreline launching or landing will be permitted. The boat ramp will be closed at night to trailered watercraft launch and retrieval. Overnight beaching of boats are allowed. The reservoir will close to trailered watercraft approximately October 30, 2011.

## San Luis Lake State Park (Alamosa County)

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Entire boating season inspection hours (from May 15-September 15) are 9am to 5pm Thursday, 9am to 8pm Friday, 8am to 8pm Saturday, and 8am to 5pm Sunday. Outside of the inspection hours, boats are required to have valid preinspection documentation (seal and receipt) prior to launch. The park is closed to trailered watercraft from September 16-May 14.

## **Spinney Mountain Reservoir State Park (Park County)**

Opening and closing dates are dependent upon weather and water level; see the "Conditions" section for this park at the State Parks website www.parks.state.co.us for updated information. Unless otherwise stated on the webpage, boat inspection hours are: Entire boating season inspection hours, from April 1 or April 15 (ice dependent) -November 30, are 1/2 hour before sunrise to 1/2 hour after sunset at the North and South boat ramps.
