Explain: **Waters evaluated in this AJD are associated with a planned photovoltaic electric power plant in unincorporated Luna County, New Mexico. Figures C1 and C2 of the Kleinfelder report (Kleinfelder 2015) provide overview maps of the project area. The site is 344 acres, 225 of which are proposed for construction. The site contains 3 ephemeral drainages which are the subject of this AJD. Only the portions of the 3 drainages that are located within the development site boundaries have been evaluated for jurisdiction. The applicant (Kleinfelder on behalf of TPE Alta Luna LLC) also evaluated**

The applicant’s review included the following:

- **National Wetlands Inventory:** No wetlands, ponds or streams are located on the property.
- **National Hydrography dataset:** Mapped streams are located on the property.
- **USGS Maps:** The Nutt 7.5-minute Topographic Quadrangle map identified the project area as undeveloped open land with hydrographic features. Several unnamed streams transect the site generally from north to south. The three streams are designated as Hydrological Features A, B, and C (see Figure 5 of Kleinfelder 2015).
- **On-the-ground review:** The three streams were observed during a routine geotechnical investigation on April 29, 2015. Photos of the three streams are included in Attachment B of the Kleinfelder report (Kleinfelder 2015).

Hydrological Features B and C flow for approximately 5,000 linear feet each within the project area before they flow into hydrological feature A. Hydrological feature A traverses the project site to the south for approximately 10,000 linear feet and terminates approximately 14,000 feet south of the project in Section 32 Township 20 South Range 6 West. Figure C3 (Kleinfelder 2015) illustrates the terminus of Hydrological Feature A. The next closest hydrological feature is located 1,450 feet south of the terminus of Hydrological Feature A. It is unlikely a groundwater connection exists between Hydrological Feature A and the feature that arises 1,450 feet south of its terminus. Groundwater flow in this area is limited by a shallow bedrock which creates a constriction to flow (Finch 2008). The closest TNW to the project site is the Rio Grande which is more than 25 miles away. The site is also located within the Mimbres Basin which is a hydrologically closed basin (Finch 2008).

On-the-ground photography does not provide evidence of an identifiable ordinary high water mark (OHWM) for hydrological features B and C. The vegetation present in both hydrological features B and C is characterized by predominantly upland species which has covered any evidence of a defined bed and bank. Hydrological Feature A which traverses the project site shows evidence of an OHWM as well as, a defined bed, sorted substrate, and evidence of occasional flow. The on-the-ground photography in attachment B indicates possible jurisdiction for hydrological feature A. However, hydrological feature A exhibits no connection to the closest TNW the Rio Grande as described above.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
