Explain: **The small ephemeral channels (i.e. drainages) within the Review Area (RA) of this AJD are located on the Pueblo of Sandia (Pueblo) and originate in the foothills of the Sandia Mountains (see attached maps). The drainage area is approximately 4.2 square miles. These drainages exhibit discontinuous channel morphology and discharge to uplands with the closest termination point of channel morphology being 2.3 miles east of the Rio Grande. As such, the drainages within the RA are determined to be isolated with no substantial nexus to interstate or foreign commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

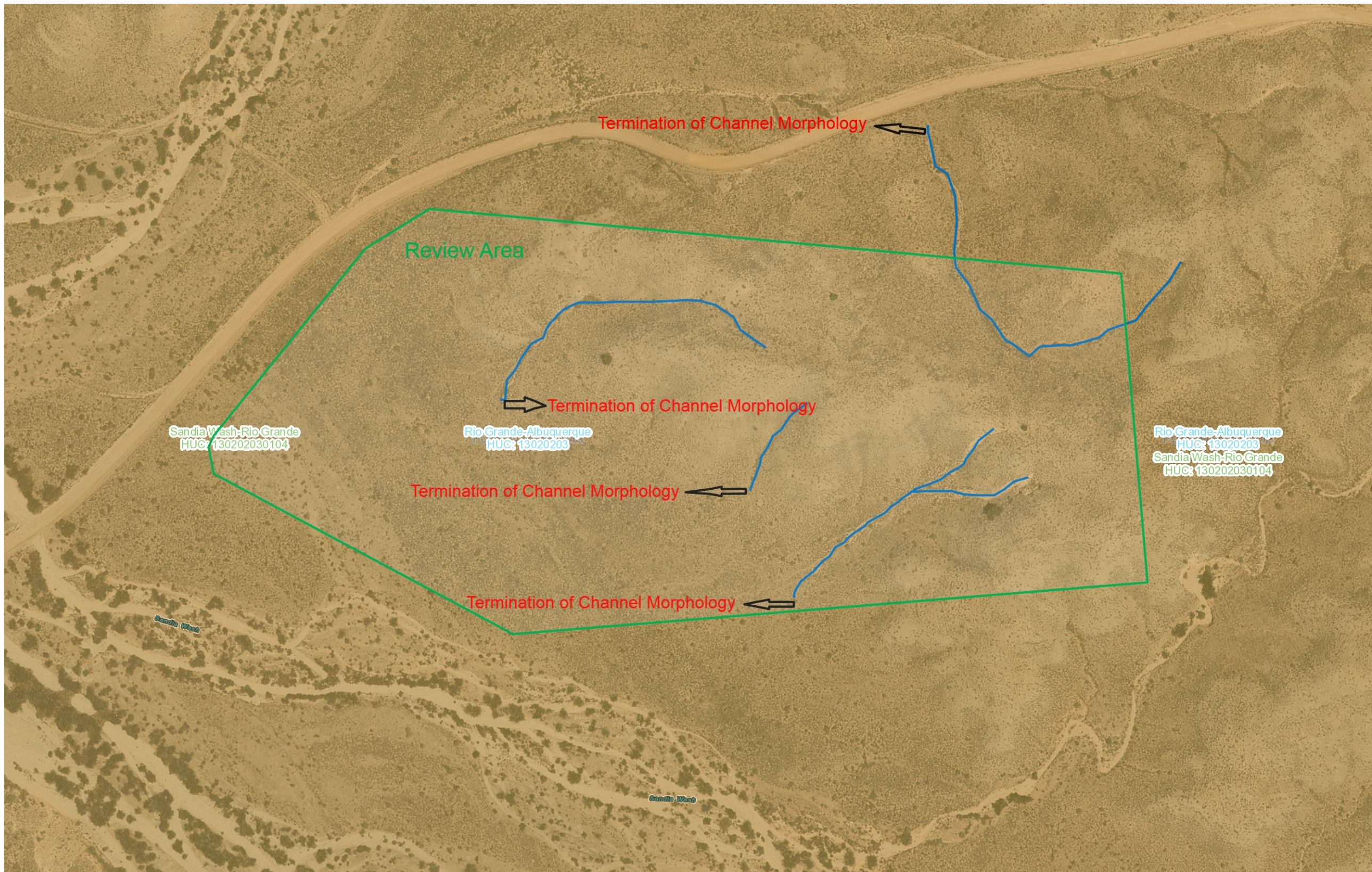
B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Pueblo of Sandia has requested an AJD for a relatively small RA located within the Rio Grande-Albuquerque Hydrologica Unit Code (HUC). The drainages within the RA originate in the foothills of the Sandia Mountains and convey flows only during large storm events. They are located in an area that receives approximately 8.86 inches average annual rainfall and approximately 6.9 inches average annual snowfall. These drainages vary in width from 1 to 2 feet and exhibit discontinuous channel morphology along their respective alignments.

The drainages within the RA discharge to uplands with the closest point of channel morphology termination being at 2.3 miles east of the Rio Grande. As such, they are determined to be isolated with no substantial nexus to interstate or foreign commerce. The maps and photographs provided as attachments to this form support this determination.

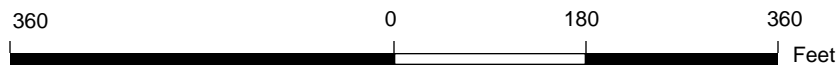


Approved Jurisdictional Determination: Pueblo of Sandia Proposed Shooting Range, Sandoval County, New Mexico

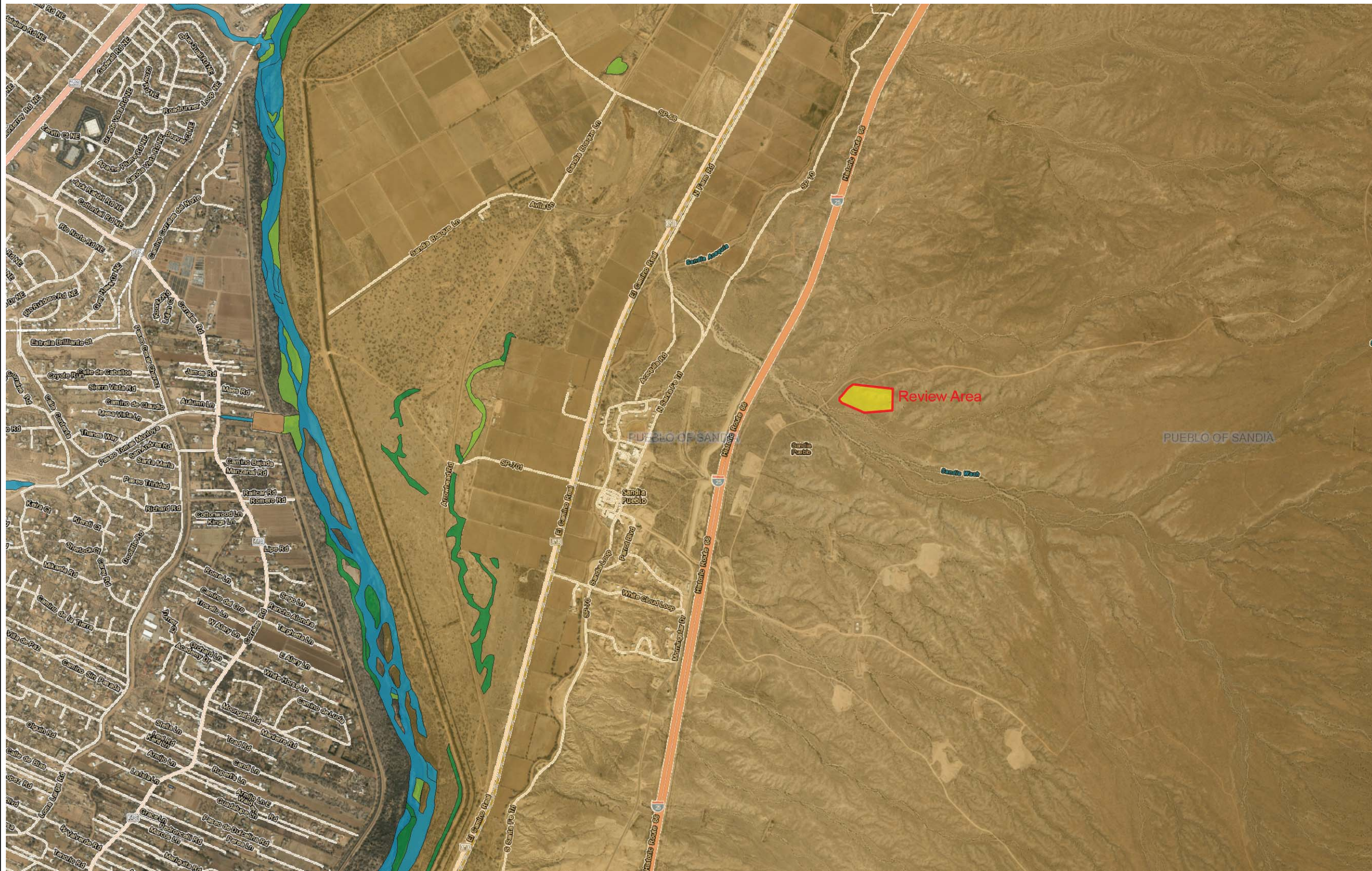

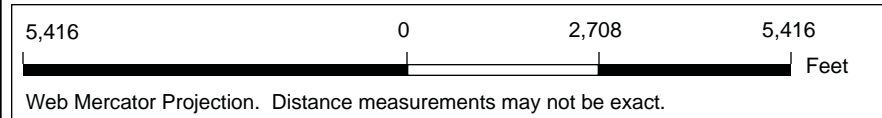
