C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Laguna Grande is also isolated and has no surface water connection to any jurisdictional water of the United States. Both playas as well as several unnamed playas are located in Nash Draw, a subsidence valley in the**

Southern Great Plains Region, are all ephemeral and normally dry during warm months. Groundwater research studies of the local area have not identified any subsurface connections between either playa lake and the Pecos River, the nearest jurisdictional water of the US. There is no historical or known prehistoric connection outlet between Laguna Grande and the Pecos River. There are no wetlands within or adjacent to, Laguna Tres and Laguna Grande. Neither playa lake waters have any connection to interstate commerce. Laguna Grande salt deposits are collected and sold for road, industrial and water softener uses during periods when no surface waters are present. According to Office of Counsel, this does not constitute a interstate commerce connection for Laguna Grande. Laguna Tres has no connection of any type to interstate commerce. Therefore, both Laguna Tres and Laguna Grade are isolated, non-navigable isolated waters with no connection to interstate commerce and not regulated under Section 404 of the Clean Water Act.
