If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

has installed a CMP culvert. The culvert is mostly filled with sediments and storm flows routinely overtop the county road and continue downhill through the former retention pond site and Ms. Tapie's property. The former drainage channel is now a vegetated swale and surface drainage has gone to sheetflow. Although the drainage had historically drained to the Arroyo de los Barrancos to the south of CR 126, houses have been built, the land has been regraded and CR 126 was improved by elevating the roadbed by 4 to 5 feet and capping with asphalt. The stormwater drainage waters now pond on Ms. Tapie's property and have no access to any other jurisdictional water. The nearest jurisdictional water, the Arroyo de los Barrancos, is approximately 1000 linear feet from her property. The drainage has no substantial nexus to instersate commerce and it is completely within Santa Clara Pueblo tribal boundaries. Therefore the drainage is an isolated, non-jurisdictional water with no connection to interstate commerce.
