Explain: **The unnamed arroyo is not a Water of the United States and does not have a significant nexus to a Traditional Navigable Water (TNW). The closest TNW to the unnamed arroyo is the Rio Grande, located 58 miles away within the Rio Grande Basin. This unnamed arroyo is located near the City of Alamogordo in the Tularosa Basin at 32.839 degrees Latitude and -105.9888 degrees Longitude. The arroyo is ephemeral in nature; it carries water only during storm events, and does not carry water for extended periods of time. The Tularosa Basin is a closed basin with no outlet point. The lowest point within the Tularosa Basin is Lake Lucero located in Dona Ana County, New Mexico at 32.702 degrees Latitude and -106.439 degrees Longitude. The unnamed arroyo is located**

over 27 miles away from Lake Lucero and flows for approximately three miles to the southwest of Alamogordo and terminates in a desert scrubland. The majority of the arroyo flows within a single channel void of vegetation and habitat for biological life due to impacts of the surrounding airport. There is no interstate commerce within the arroyo nor would degradation to this arroyo have an effect on interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
