C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The following discussion addresses only California Gulch and the unnamed tributary to Whitewater Creek. Deadman Canyon is addressed in a separate AJD form. The request for an AJD was made by Freeport McMoRan Tyrone Inc. (FMI).

SIGNIFICANT NEXUS ANALYSIS

The relevant reach of California Gulch and the unnamed tributary to Whitewater Creek were determined to have no physical, chemical, or biological nexus to the downstream TNW, the Gila River. Figure 8 of the HilgartWilson report shows the locations of these stream reaches.

The ordinary high water mark (OHWM) for these streams was mapped by HilgartWilson utilizing the Corps Arid West OHWM Delineation Manual. The upstream reach of California Gulch is intercepted by the Little Rock mine and flows are directed to main sump at the bottom of the Little Rock Mine open pit. Downstream and north of the open pit California Gulch is steep and narrow. Where the gradient lessens California Gulch begins to exhibit indicators of an OHWM for approximately 1000 feet. The unnamed tributary is a small side canyon that conveys flow to Whitewater Creek. The segment of the unnamed tributary that exhibits characteristics of an OHWM is approximately 260 feet in length. The combined acreage of these stream segments that exhibit an OHWM is 0.16 acres. (HilgartWilson 2017).

There is no indication that the segments of California Gulch and the unnamed tributary described above contribute sediment or have a physical nexus to the downstream TNW. There are no known chemical contaminant sources within these segments. Also, there is no habitat that would create a wildlife corridor from these streams to the downstream TNW and no information available that indicates these streams provide any significant biological life support imports (organic carbon, etc) to the Gila River.
