FACSIMILE MODIFICATIONS

(a) Definition. Facsimile modification to a proposal, as used in this provision, means a revision or modification of a proposal, or withdrawal of a proposal that was originally transmitted to and received by the Government in hardcopy, via mail or hand-carried. Please note: Express mail packages must be sent to the street address only, in enough time to reach the Contracting Division before **3 PM (MST) 7 March 2003**.

(b) Offerors may submit facsimile modifications as necessary to this solicitation. Faxed modifications are subject to the same rules as paper modifications. This includes the signature of the Contractor offering the modification. The faxed modification must not consist of more than 5 pages.
