Site conditions: Earthfill dam on an ephemeral arroyo upstream (east) of I-25 and the Town of Bernalillo.

NJD Rationale: Flows exiting Piedra Liza Dam cross under I-25 in culverts. Flows continue west in a poorly defined channel and end abruptly at the BNSF railroad grade (ponding, ground re-charge). Flood flows (not ordinary high flows) continue south along the railroad grade in an indistinct swale. The arroyo does not discharge to any jurisdictional waters of the U.S. and has no nexus to interstate or foreign commerce.

Navigation/interstate commerce: The site is located on public property and has no connection to interstate or foreign commerce or navigation. The site is not located on tribal land nor does the arroyo extend across a tribal boundary.

Waters of U.S. onsite: There are no waters of the U.S. on the site.
