Acequia Restoration and Rehabilitation Program

Section 1113 **(Water Resources Development Act of 1986)**

At a Glance:

- Acequia – water and irrigation system related infrastructure projects.
- Project cost-shared 75/25 with non-Federal partner or at 90/10 for qualifying economically disadvantaged communities and Federally recognized Indian Tribes.
- Projects are generally medium to large in scope.
- Design and construction support.

The Authority. Section 1113 of the Water Resources Development Act 1986, as amended, provides authority for the U.S. Army Corps of Engineers to enter into cost sharing agreements with non-Federal sponsors to protect and restore Acequia Systems throughout the state of New Mexico. Under the Section 1113 authority, assistance may be in the form of design and construction for irrigation water related infrastructure system projects.

Project costs are shared on a 75% Federal, 25% non-Federal basis unless in the case of a measure benefitting an economically disadvantaged community (as defined by the Secretary under section 160 of the Water Resources Development Act of 2020 (33 U.S.C. 2201 note)), whereas the Federal share of the cost of carrying out such measures shall be 90% and 10% non-Federal. Further, section 341 of WRDA 2022 sets the cost share at 10% for Federally recognized Indian Tribes. The non-Federal sponsor shall receive credit for land, easements, rights-of-way, and relocations toward the non-Federal share of project costs not to exceed 25% of the total project costs.

The Process. A non-Federal sponsor that has the legal and financial capability to enter into an agreement will provide the Corps of

Engineers a request for assistance under the program.

The non-Federal sponsor must have the legal and financial capability to fulfill the following project partnership requirements:

- Contribute the non-Federal share of the project costs
- Establish and maintain procedures necessary to insure the long-term operation of the project
- Hold and save the Government free from all damages arising from design, construction, operation, maintenance, repair, rehabilitation, and replacement of the project
- Assume 100% of the operation and maintenance costs for the project when completed

How to Request Assistance. If you have a need for design and construction for Acequia related assistance that may fit within the Section 1113 authority, please contact the Albuquerque District at the phone number below. Our Acequia Program Manager will be happy to meet with you to determine whether the proposed project fits within the program's authority. Only upon receipt of a letter of request/intent from a non-Federal sponsor can the Corps of Engineers initiate a project.
