Explain: **A single ephemeral arroyo is included in this determination. It is located on Ceja Mesa within the city limits of Rio Rancho, New Mexico. This arroyo has an approximate drainage area of 0.35 square miles and conveys flows resulting from major storm events to uplands. This drainage extends for about 1 mile and exhibits a poorly-defined**

channel along the majority of its alignment. Its channel morphology terminates at the intersection of Viga Road and 19th Avenue SE and flows from this juncture are conveyed down these roadways and as sheet flow across the landscape to the southeast. This point is approximately 0.6 miles north of the Calabacillas Arroyo. As such, the subject arroyo is an isolated water and has no physical surface connection with a Traditional Navigable Water.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The applicant has requested an approved jurisdictional determination (AJD) for an ephemeral arroyo located within the Rio Grande-Albuquerque Hydrological Unit Code. The Subject Arroyo included in this determination is located at Ceja Mesa (also referred to as the West Mesa or Llano de Albuquerque) within the city limits of Rio Rancho, New Mexico. This geographic area is characterized as a remnant basin-plain situated at an elevation of 140 to 250 meters above the Rio Grande. It is heavily dissected by irregular hills and valleys; and areas dominated by fluvial processes exhibit vertical incision and lateral channel migration (Bailey 1999).

The subject arroyo has an approximate drainage area of 0.35 square miles and conveys flows resulting from major storm events to uplands. Annual rainfall for this general area averages about 8.7 inches. This drainage extends for about 1 mile and varies in width from 8 to 16 feet. Segments of this drainage are poorly defined and lack an ordinary high water mark. Its channel morphology terminates at the intersection of Viga Road and 19th Avenue SE and storm flows from this juncture are conveyed down these roadways and as sheet flow across the landscape to the southeast. This point is approximately 0.6 miles north of the Calabacillas Arroyo. A recently constructed housing subdivision is located south of this channel's termination point and north of the Calabacillas Arroyo. The subject arroyo is an isolated water and has no physical surface connection with the Calabacillas Arroyo and, therefore, none of its downstream waters (i.e. the Rio Grande). The maps and photographs provided as attachments to this AJD form support this determination.

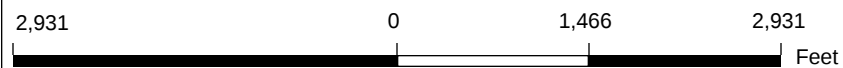

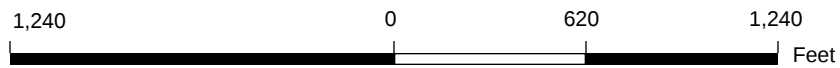
