MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023),<sup>1</sup> SPA-2022-00473<sup>2</sup>.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

3. REVIEW AREA. The review area consists of a 3,524-acre parcel located at approximately Latitude 38.4465, Longitude -104.237051, Section 33, Range 61W, Township 18S, Pueblo County, Colorado. The applicant has requested the review of one (1) aquatic resource located within the review (i.e., WT-A1)

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), THE TERRITORIAL SEAS, OR INTERSTATE WATER TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The aquatic resources within the review area have no connection to a TNW, territorial sea, or interstate water.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, THE TERRITORIAL SEAS, OR INTERSTATE WATER. The aquatic resources onsite do not have a surface water connection to a TNW. There were no flow paths identified between the aquatic resources within the review area and the Haynes Creek 4.6 miles to the west or upper Kramer Creek 2.5 miles to the east.

WT-A1 is a 0.13-acre palustrine emergent wetland which receives water from a pipe attached to a water storage tank for livestock. The wetland does meet all three characteristics to meet the definition of a wetland. There is an intersection for a dirt road which appears to collect water in the identified wetland. These roads bound the wetland on the west, south, and east. WT-A1 is an (a)(4) wetland which is not adjacent to and has no continuous surface connection to any (a)(1) waters including traditional navigable water, interstate water, the territorial seas, or an (a)(3) relatively permanent tributary or an (a)(2) impoundment, therefore WT-A1 is isolated and non-jurisdictional.
