B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The review area is located adjacent to Navajo Route 365 and consists of previously disturbed uplands ranging from approximately 25 – 50 feet above the San Juan River. The applicant has provided a project map identifying the limits of where work would occur and a site visit was conducted by a representative of the U.S. Army Corps of Engineers on April 30, 2019. Based on the evaluated data, site inspection, and project map, the area of review is determined to contain only dry lands.
