### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The review area contains an approximately 0.1-acre wetland that likely receives excess water from multiple (3) chlorination tanks on site. A dishcarge pipe extending from the chlorination tanks and into the wetland was visible during a site visit conducted on 12/7/21. The wetland is bounded on all sides by upland vegetation and resides in a linear depression

with no visible outlets. There is no surface connection to a TNW and no evidence of a subsurface connection. The closest TNW is the Colorado River, which is approximately 175 miles to the northwest.
