# MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 SPA-2024-00237<sup>2</sup>.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

# 1. SUMMARY OF CONCLUSIONS.

a. Provide a list of each individual feature within the review area and the jurisdictional status of each one (i.e., identify whether each feature is/is not a water of the United States and/or a navigable water of the United States).

The study area appears to be located in the Taos USGS 1:24K Quad. Based on historic aerial imagery and current observations, most of the site appears to be upland scrub/shrubland. The study area is mostly undeveloped with some residential scattered within the area and can best be characterized into one distinct vegetation type: 1) *arid scrub/shrub*. According to the USDA Soil Survey, the mapped soil type within the study area is not located on the Taos County hydric soils list, suggesting wetlands would not be expected. According to the USGS Topographic map, no aquatic features are located within the study area. No aquatic features were observed on this site. This site is comprised entirely of uplands.

It has been determined that the study area is comprised entirely of uplands.

- 3. REVIEW AREA. The review area consists of a 5-acre parcel of land, approximate center point of latitude 36.386043°N, longitude 105.556586°W, Taos County, New Mexico. The applicant has requested the review for aquatic resources located within the review area.
