Explain: **The project site contains 9 potentially jurisdictional wetlands which are considered isolated. None of the wetlands have a substantial nexus to interstate commerce. They are all located on private non-recreational land, none sustain fish or shellfish populations, and none are used for industrial purposes.**

Wetlands No. 6 are two wetlands located on an upland swale which has been isolated by Briargate Boulevard street construction and overlot grading. Any upland swale connection between the wetlands and other waters has been severed for 2 - 3 years by the non-regulated street construction and overlot grading.

Wetlands No. 7-W and No. 7-E are two separate wetlands located on two faintly-defined upland swales in a rolling hills topography. The swales have no obvious connection to other waters.

Wetland No. 8-E is an open-water stock pond created by excavating and berming a low spot on the landscape. There is no outlet from the stock pond and thus no connection to other waters.

Wetland No. 8-W is located within an upland swale which connects to the 9-E wetland.

Wetland No. 9-E is an abandoned stock pond created by excavating and berming the swale. There is no outlet from the pond and thus no connection to North Pine Creek, which is located down-swale from this wetland.

Wetlands No. 9-N are two wetlands, each within an abandoned stock pond created by excavating and berming uplands. There are no swales and no outlets to the ponds and thus no connection to other waters.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This is a reissuance of an expired approved JD for the project. Original approved JD was reviewed by the EPA and issued by the Corps on August 30, 2007. Applicant contacted the Corps and requested the extension since the original approved JD was limited to 5 years. Project was delayed due to the economy, and both the design and the water resources reviewed are unchanged from 2007 to the present.

The project site contains 9 potentially jurisdictional wetlands which are considered isolated. None of the wetlands have a substantial nexus to interstate commerce. They are all located on private non-recreational land, none sustain fish or shellfish populations, and none are used for industrial purposes.
