Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The review area for this determination is limited to Wetland Drainage A (1.62 acres) and Wetland Drainage C-D (1.29 acres) located on the approximately 62-acre tract. Wetland Drainage B is not included with this determination. Wetland Drainage A and Wetland Drainage C-D were previously determined by the Corps in 2006 to be isolated aquatic resources not subject to Section 404 jurisdiction. Based on a review of the National Hydrography Dataset (NHD) the nearest waterway is an unnamed tributary to Black Squirrel Creek located approximately 700 feet southeast of both wetlands, with mapped uplands severing a surface connection to the waterway. Due to their small size and/or disturbed characteristics, Wetland Drainage A and Wetland Drainage C-**

D provide limited habitat functions to surrounding areas and exhibit tenuous ecological connections to nearby surface waters. Corps staff conducted a field visit on March 17, 2022, and confirmed that Wetland Drainage A and Wetland Drainage C-D lack a surface connection to the unnamed tributary to Black Squirrel Creek. Based on this information, the Corps has determined that Wetland Drainage A and Wetland Drainage C-D are isolated features with no surface or shallow subsurface hydrologic connection or ecological connection to a RPW or TNW. Wetland Drainage A and Wetland Drainage C-D do not border, neighbor, nor are contiguous with another water of the U.S. Wetland Drainage A and Wetland Drainage C-D are not separated from other WOUS by man-made dikes, barriers, or berms. Wetland Drainage A and Wetland Drainage C-D do not support a link to interstate or foreign commerce; they are not known to be used by interstate or foreign travelers for recreation or other purposes; They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and they are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland Drainage A and Wetland Drainage C-D are not regulated by the Corps under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
