Fillmore and I-25. The three discharge storm water points east of the Interstate Highway 25 were inspected with no observance of water flows on the present three discharge points along Monument Creek; considered a waters of the U.S. Based Navigable Water Protection Rule, findings and best available information wetlands A and B are physically separated from Monument Creek by Interstate highway 25 where no direct hydrologic surface connection occurs between the wetlands A and B and Monument Creek in a typical year.
