C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The property in question contains two wetlands; an 0.605-acre palustrine emergent (PEM) wetland (northwest area) and an 0.726-acre palustrine scrub-shrub (PSS) wetland (southeast area). Based on the site assessment prepared by Ecosphere Environmental Services, wetland hydrology, hydric soils, and hydrophytic vegetation characteristics supported the delineation of aquatic resources. Soils within both the PEM and PSS wetland areas displayed hydric soil indicators in the upper 12" of the soil surface including oxidized rhizospheres, depletions and redox concentrations. The hydrology on the Property is predominantly sourced by stormwater and snowmelt that flows south and down gradient through a culvert from the depressional topography to the north to the subject. Soils were saturated in the upper 12" of soil surface near the culvert outlet within the PEM wetland area and the depressional PSS wetland reflected loam soils with saturation within 8" to 12" of soil surface reflecting hydrology during the site assessment. Dominant hydrophytic vegetation of the Western Mountains Valley and Coast Region identified within the PSS and PEM wetlands of the Property by Ecosphere Environmental Services include drummond willow (*Salix drummondiana*), Baltic rush (*Juncus balticus*), common timothy (*Phleum pratense*), and curly dock (*Rumex crispus*). Hydric vegetation reflected signs of normal growth and condition for the 2021 growing season. Based on previous AJD evaluation (SPK-2018-00794), the basin these wetlands are located within does not have an outlet. There is no surface connection to a Traditional Navigable Water (TNW) and no evidence of a subsurface connection. The closest TNW is the Animas River, which is approximately 1,500-linear feet to the southeast.
