C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland 1 (W1), an appromately 1.52-acre PEM wetland, is situated aong the north side of the unnamed road that traverses the southern boundary of the 123-acre project area. Wetland 1 flows via a culverted road corssing into Wetland 2 (W2), an approximately 0.02-acre PEM wetland, that is situated in a roadside ditch on the southside of the unnamed road. The roadside ditch is part of a complex of roadside ditches associated with the roads and railroads in the PuebloPlex and Pueblo Army Chemical Depot. Chico Creek, Boone Creek, and multiple unnamed tributaries to the Arkansas River are all located more than 1.5 miles from the project. Data sheets provided by the consultant identified a restrictive clay layer approximately 5 to 7 inches below the soil surface of W1 and W2, which perches and prevents surface water from draining after storm events. Based on the lack of surface water connections to the aforementioned streams, these wetlands do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these wetlands are not regulated by the Corps under Section 404 of the Clean Water Act.
