Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The Welton Ditch and associated unnamed ditch provide irrigation water from the Huerfano River to historically upland areas. Wetlands A, C, E, G, H, K, and M are irrigated areas for cattle ponds. If irrigation would cease, these areas would convert back to uplands. Wetlands B, D, and I are due to the leaky Welton ditch and overflow events. Wetlands F, J, L are located near cattle ponds and are due to overflow of these areas. The project site contains 7,728 linear feet of ditches and 9.57 acres of wetlands. The ditches within the review area are constructed in uplands and do not convey water to waters of the United States. This determination is in accordance with the 1986 preamble to 33 CFR Part 328.3, which states that the Corps generally does not consider artificially**

irrigated areas which would revert to uplands if the irrigation ceased to be waters of the United States. In addition since the wetland area is solely supported by irrigation water, the wetland area would revert to upland in the absence of irrigation. Therefore, the area in question is not a wetland as defined by 33 CFR 328.3, since the area would not support a prevalence of vegetation under normal circumstances. In addition, the Corps generally does not consider artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering or irrigation.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
