Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The project site contains 6.69 acres of irrigated wetlands, 0.80 acre of water treatment pond, 0.02 acre of open water, and 0.14 acre of ditch wetland. The irrigated wetlands (labelled Wetland 3) along the north side of the project area are supported by historic irrigation water via Ditch 1, 2, and 3. The 1986 preamble to 33 CFR Part 328.3, which states that the Corps generally does not consider artificially irrigated areas which would revert to uplands if the irrigation ceased and stock ponds constructed in uplands to be waters of the US. In addition, since wetland 3 is solely supported by irrigation water, the wetland area would revert to upland in the absence of irrigation. Therefore, wetland 3 is not a wetland as defined by 33 CFR 328.3, which defines the term "wetland" as**

those area that are inundated or saturated by surface or ground water at a frequency and duration sufficient to support, and that under normal circumstances do support a prevalence of vegetation typically adapted for life in saturated soil conditions. Since the area would not support a prevalence of vegetation under normal circumstances, it is not a waters of the United States. In addition, 33 CFR 328.3 clarifies that waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of the Clean Water Act are not waters of the United States. Furthermore, ditches that are constructed in uplands and that do not flow into waters of the United States, are not tributaries as defined in 33 CFR 328.3 and are not waters of the United States. Ditch 1, 2, and 3 terminate within the irrigated wetland and do not flow into a waters of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
