Summarize rationale supporting determination: SPA and SPK Traditional Navigable Water; Navigable In-Fact Determination for the San Juan River dated September 10, 2007. Additionally, in April 2022, SPA reassessed that determination, in accordance to Appendix D of the Rapanos Guidance, and determined the San Jaun River is a Traditional Navigable Water; Navigable In-Fact. This determination was based on the fact that there are numerous commercial rafting companies that utilize this stretch (i.e., from the US Highway 160 Bridge Crossing east of Pagosa Springs to Navajo Reservoir) of river in Colorado and that commercial rafting companies (e.g., Pagosa Adventure and Canyon Rio Rafting Company) generally utilize the river east of Pagosa Springs (i.e., Pagosa Riverside Campground) and continue to Eight Mile Mesa (~ 17 miles) and then to Navajo Reservoir. These commercial rafting companies serve several hundred to a thousand customers during the rafting season, with a large percent of the customers being from out-of-state who pay these companies to utilize their services for navigation purposes.

**2. Wetland adjacent to TNW**

Summarize rationale supporting conclusion that wetland is “adjacent”: “Adjacent,” as defined in Corps and EPA regulations, means “bordering, contiguous, or neighboring.” Wetlands separated from other waters of the United States by man-made dikes or barriers, natural river berms, beach dunes and the like are ‘adjacent wetlands.’ Wetland A is separated, by a man-made dike or barrier from the San Juan River. Aerials from 1991, 1950, and 1936 show evident saturation from Wetland A to the San Juan River, indicating that at one time, Wetland A directly abutted the San Juan River. A man-made dike or barrier that appears to serve as an access road separates Wetland A from an upland swale that exists between the berm and the San Juan River. There is not a culvert under this dike or barrier. Aerial images dated 2011, 2013, and 2016, along with the presence of mineral precipitate within the swale, indicate that Wetland A, whose source of hydrology is a geothermal seep, contributes hydrology through shallow groundwater to the San Juan River. The geothermal hydrology contains a high mineral content. The geothermal hydrology contains a high mineral content and in aqueous solutions, precipitation is the process of transforming a dissolved substance into an insoluble solid (i.e., precipitate).

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

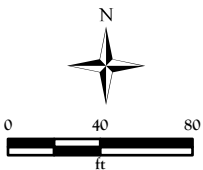
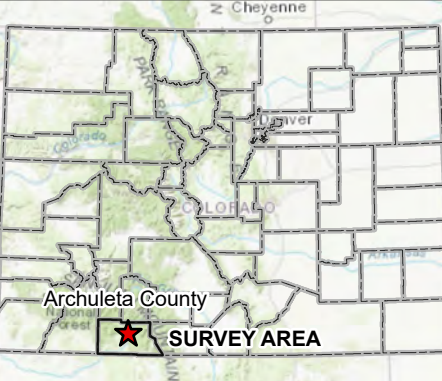

**GENERAL NOTES**

1. SME Environmental, Inc. (SME) staff visited the site on April 2, 2021 to assess and delineate the boundaries of wetlands and other Waters of the U.S. (WOUS) in the area of interest using the methodology defined in the Routine Determination procedure set forth in the U.S. Army Corps of Engineers Wetlands Delineation Manual (USACE 1987), the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Arid West Region (USACE 2010), the Field Guide to the Identification of the Ordinary High Water Mark (OHWM) in the Arid West Region of the Western United States (USACE 2008), and the USACE Jurisdictional Determination Form Instructional Guidebook ("Rapanos Guidance") (USACE 2007)

2. Wetland boundaries were defined based on presence of hydrophytic vegetation, hydric soils, and hydrologic indicators that under normal conditions would indicate wetland conditions. Where wetland conditions did not occur adjacent to surface water, the jurisdictional boundary was identified based on evidence of the OHWM.

3. The boundaries of WOUS were survey-located using a Trimble R1 GNSS Receiver (real-time sub-meter accuracy).

4. All aquatic resource boundaries, depicted hereon, are subject to modification until jurisdictional verification has been completed the USACE.

5. Please be aware that impacts to aquatic resources may require authorization from Local, State and/or Federal regulatory agencies.

6. Aquatic resources delineation table represents acreages, linear footage, square footage and centroid locations.
