C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The project area is located approximately 3.9-miles south of Divide, Colorado and comprises approximately 80-acres as depicted on the map set provided in the aquatic resource delineation report prepared by Ecological Resource Consultants, Inc. (ERC), dated December 13, 2022. The project area is located within the Natural Resources Conservation Service’s (NRCS) designated Land Resource Region (LRR) E-Rocky Mountain Range and Forest Region, specifically within Major Land Resource Area (MLRA) 48A-Southern Rocky Mountains. Within this MLRA, the project area is found within the Southern Rocky Mountains Province of the Rocky Mountain System (NRCS 2006). The Southern Rocky Mountain portion of this MLRA is composed of strongly sloping mountains trending north to south. Elevations within the MLRA range from 6,500 to 14,400 feet. Average annual precipitation within the MLRA ranges from 7 to 63 inches with half of the precipitation occurring as snowfall in the winter, which increases with elevation. The higher elevation areas of the MLRA generally accumulate deep snowpack that may persist into spring and summer resulting in snowmelt fed streams which may contain surface flows for several months to year-around.

ERC conducted an onsite aquatic resource delineation of the review area on 7 Sept. 2022. Two (2) wetlands (i.e., Wetland-A & B) and one (1) perennial stream (i.e., Fourmile Creek) were identified as a result of the delineation. Wetland-A consists of 2.49-acres of

palustrine emergent wetland (PEM) and 0.22-acre of palustrine scrub-shrub wetland (PSS) located at the western boundary of the review area between the active gravel mine site and CO-67. A culverted entrance road to the mine bisects a portion of Wetland-A. Photos taken by ERC indicate hydrology from the northern half of Wetland-A has not been completely disconnected from the southern half as indicated by the observance of a relatively permanent surface flow connecting both portions of Wetland-A. Other data sources verify the presence of relatively permanent waters (RPW) within Wetland-A prior to the construction of the entrance road. Google Earth and Digital Globe aerial imagery indicate this RPW is present as a small area of open water within both halves of Wetland-A, which continues to Fourmile Creek creating a confluence between the two aquatic resources. A tributary originating from the west side of CO-67 enters the southern half of Wetland-A, via culvert, and contributes additional flows to the Wetland-A. The delineation report and aerial imagery indicate the southern half of Wetland-A extends the entire length of the western boundary of the review area and continues past the review area to Fourmile Creek. The northern half of Wetland-A abuts a relatively permanent water (RPW) connected to the southern half of Wetland-A, while the southern half of Wetland-A is one large contiguous wetland abutting Fourmile Creek, an RPW.

Wetland-B and Fourmile Creek are located along the eastern boundary of the review area and extend along most of this boundary. Wetland-B consists of 2.2-acres of palustrine forested wetland abutting Fourmile Creek on both sides along most of the 1,494-foot-long creek length within the review area. Fourmile creek is a known RPW and tributary to the Arkansas River.

The information collected by the Corps and submitted by the applicant indicate the northern half of Wetland-A abuts an RPW that flows into the southern half of Wetland-A via a culvert, while the southern half of Wetland-A and Wetland-B abut Fourmile Creek, an RPW. Based on the information above, the Corps has determined Wetland-A, Wetland-B, and Fourmile Creek (i.e., Aquatic Resource B) are waters of the U.S. under Section 404 of the Clearwater Act.
