B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

It appears that there is no ecological connection from this site to the TNW since the duration of a storm event and magnitude of flows would rarely make it to the RPW approx. 99 miles downhill.**

Summarize overall biological, chemical and physical functions being performed: **It appears that the site would not have a significant nexus to the TNW approx. 228 miles away. This site is a herbaceous wetland that flows during storm events that probably never make to the TNW since the flows would have to pass through many miles of sand substraigh and upland swales.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

From information obtained from local retired NRCS staff, flows from upper Black Squirrel Creek and their tributaries do not make it to Chico Creek unless there is a significant storm event. There are no connections to water right to the Arkansas River within Black Squirrel and Chico Basins and the state believes the upper areas of these basins as isolated from the Arkansas River basin except extreme events drainages. Since there are many miles of sandy substrate chemicals settles in the upland swales and would not make it to the TNW. .**
