No OHWM of the stream enters Mr. Miller's property. Wetlands occur where irrigated fields/meadows are used for haying through irrigation. We could not find an outfall into Grape Creek or wetland connection to the Miller Property.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Mr. Miller and I looked at the Dry Creek drainage from his upper head gate, down to the lower portion of his property. The upper reaches show OHWM and have wetlands. The middle reaches of Dry Creek begin to flatten in elevation and lose the OHWM, flows move through sheet flow and irrigation ditches taking flows away to irrigate hay meadows. The lower reaches consist of wet grass meadows and eventually become uplands of rabbitbrush and other upland species. There is no OHWM in the lower reaches and no wetland connection to Grape Creek (a RPW). The USGS quad shows that the Dry Creek blue line not connecting to a RPW or TNW. We believe that Dry Creek is an isolated intermitten stream with no connection to Grape Creek.
