C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Peabody Energy has requested a jurisdictional determination for four ephemeral arroyos located within the Chaco River Hydrologica Unit Code (HUC). All four ephemeral arroyos included in this AJD originate on the southern slope of Orphan Annie Rock and convey flows during large storm events. They are located in an area that receives approximately 10.5 inches average annual rainfall and approximately 10 inches average annual snowfall. These drainages vary in width and exhibit discontinuous channel morphology along their respective alignments. They are primarily defined by landforms and flows are discrete, although some reaches do exhibit ordinary high water marks and evidence of flow. On the upstream side (east), the arroyos have been heavily modified by mining activities and road construction. On the downstream side they have been significantly altered by earthen berms.

The three southern sections of the Orphan Annie Arroyo within the lease boundaries of the mine converge into a single channel near the western portion of the lease boundary. At this juncture the channel becomes poorly defined to non-existent and flows are spread across the landscape. Several earthen berms located along the arroyo act as sheet flow barriers, appearing to try and pool water at each of the locations. On the southern portion of the lease the channel becomes well-defined, deep (from 3 to 5 ft), wide (5 to 10 ft), and braided. On the central southern portion of the lease boundary, the drainage area has been altered by heavy equipment and channel morphology has been obscured. On the west end of this arroyo before it exits the lease boundary, it appears the arroyo is dry and braided. In the instance of a very large storm event, flows at this point are channeled west, but no further evidence of the arroyo channel is present about .5 miles beyond the lease boundary. As such, there is no physical surface connection between these three southern sections of Ophan Annie Draw and the Chaco River, which is over 30 miles to the north. The maps and photographs provided as attachments to this form support this determination.

The northern portion of the arroyo has also been heavily modified on both sides of the existing mine. It exhibits similar characteristics as the southern sections of the arroyo, including the lack of channel morphology/sheet flow sections along its general trajectory. This arroyo also ends at its intersection with the mine, and approximately 30 miles south from the Chaco River. As such, there is no physical surface connection between the subject arroyo and the Chaco River. The maps and photographs provided as attachments to this form support this determination.
