C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**


This jurisdictional determination was requested by the Water Resource Group in advance of their proposal to construct the Verde Residential Development located north and west of the intersection of Pete Domenici Highway and McNutt Boulevard in the City of Santa Teresa, Dona Ana County, New Mexico. The project area is shown in Figure 1 and encompasses approximately 450 acres. The review area (RA) for this AJD is the same as the project area.


A previous AJD was completed for RA in March of 2018. Based on the information provided by the applicant and reviewed by the Corps, it was determined that no waters of the United States were present. The previous AJD evaluated a total of four ephemeral stream channels. However, two of these channels are no longer existing (Figure 1).

The RA receives an average annual rainfall of 8 inches with an average annual winter snowpack of 0 inches. Based on statistical records the site receives an average daily rainfall of 0.2 inches during the monsoon season (July, August and September). This rainfall is usually due to short, intense storm events.

There are two ephemeral stream channels within the RA that drain an area of approximately 72 square miles. These ephemeral channels discharge into a southern detention pond constructed by local farmers to prevent sediment discharges and inundation of adjacent agricultural fields (Figure 2). The detention pond contains a small discharge pipe that extends through a constructed earthen embankment and drains to an adjacent concrete irrigation ditch. The irrigation ditch discharges into an adjacent agricultural field. Using 2-foot contour data for the site, it was determined that the southern detention pond can store up to 18-acre feet of water. Therefore, runoff from an average monsoon season storm is detained by the pond where it infiltrates without discharging to the fields below. The Rio Grande is the closest traditionally navigable water (TNW) to the RA, which is located approximately 5 miles from the pond where the stream channels terminate.

The ephemeral stream channels within the RA do not have a substantial nexus to interstate commerce related to navigation, recreation, or other activities. Further, these features do not contribute flows to a downstream RPW or TNW and, therefore, are isolated. As such, the RA does not contain waters of the United States.
