and are approximately 1346, 660, and 711 linear feet of isolated ephemeral arroyos. The project's purpose is to develop parcels 7, 11, 12, and 69. The three drainages each terminate in swales before reaching the Mesa Spur Drain, an irrigation canal that ultimately drains to the Rio Grande. There are no outfalls from the swales. Runoff in the 3 drainages does not enter the Mesa Spur drain, but evaporates in the terminal swales .

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

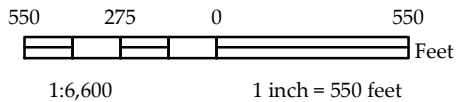

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Current conditions documented in the attached delineation report, "Jurisdictional Waters Assessment for the Paseo Del Este Parcels 7, 11, 12, and 69 and the Associated 126-acre Survey Area", indicate that water from the three drainages will not reach the Rio Grande, the nearest TNW. The terminal points for the three drainages are three swales north of the Mesa Spur Drain, El Paso, Texas.

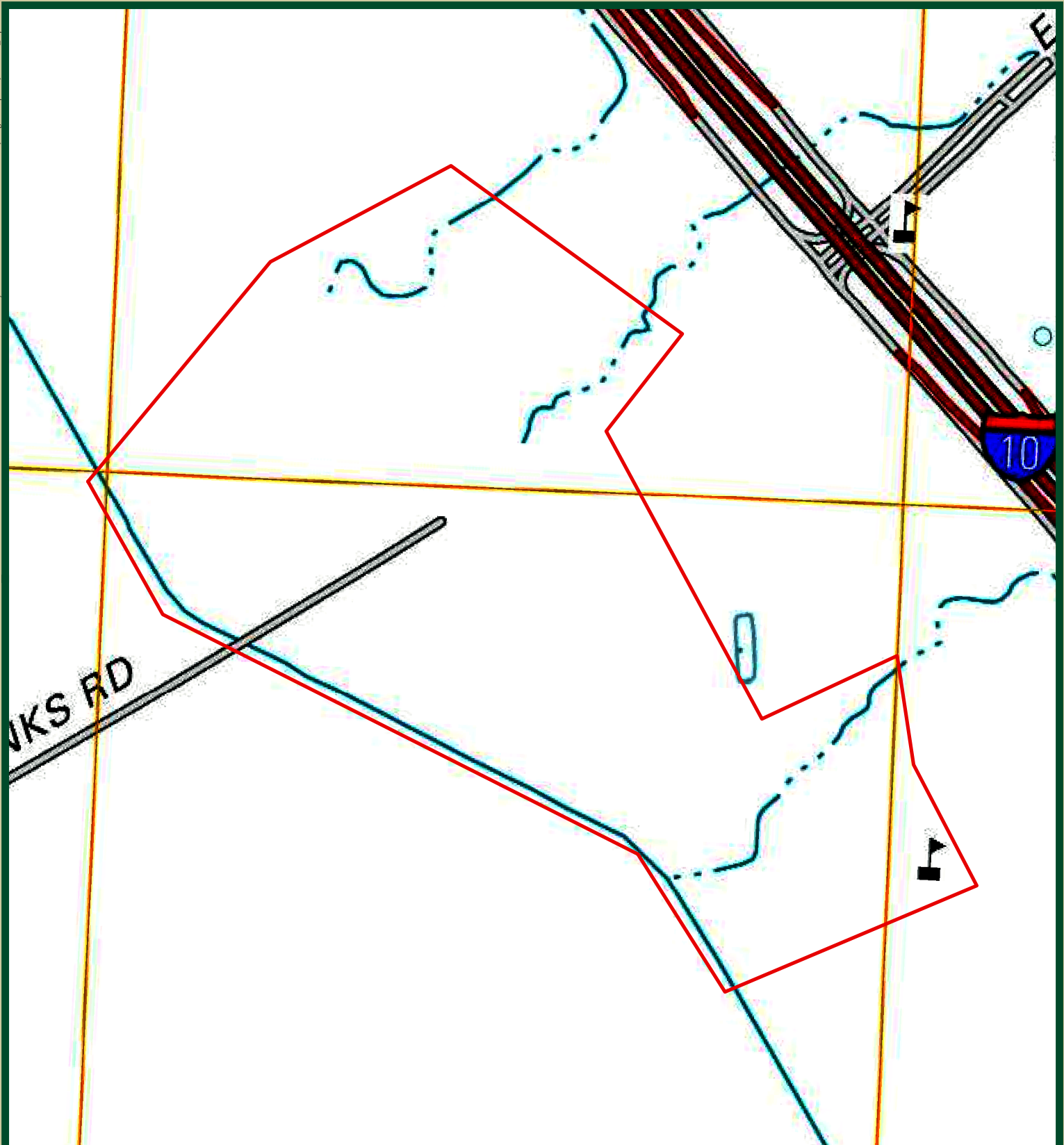

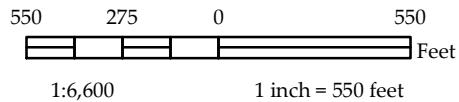



 Subject Area
