Wilson Playa is located in the Rio Penasco watershed (13060010). The area of the watershed is 686,384 acres. The average annual precipitation for the watershed is 13 inches per year (USGS, National Hydrography Dataset). Wilson Playa does not have a significant nexus to a "water of the U.S." as defined by the Clean Water Act (33 CFR part 328).

Wilson Playa is an isolated depression with the total area of 29 Acres. Wilson Playa is the terminus point for the surrounding ephemeral drains in the area; the playa has no outlet point and only receives seasonal flow during storm events (NAIP Imagery, 2013). The ephemeral drains in the area are relevantly short in length and only drain

the surrounding landscape. Based on aerial imagery most streams appear to be low order streams with very low slopes, most of the streams look to be vegetated over with upland species indicating low amounts and sporadic flow. Once the streams deliver water to the playa, the storm event would have to fill the entire playa and spill out over the top, there are no streams that connect the playa to the Rio Penasco River. Due to the low amounts of precipitation for the region the playa stays dry for the majority of the year. The closest water of the U.S. is the Rio Penasco which is located approximately .5 miles from the playa. Based on the gage data provided the Rio Penasco is ephemeral at this reach and only flows during monsoonal storm events.

Based on well gage data available from the NM Office of the State Engineer, Wilson Playa is not expected to have a ground water connection to the Rio Penasco. The elevation of the playa is 3,473 feet above sea level and the bed of the Rio Penasco is 3,475 feet above sea level (USGS, National Hydrography Dataset). Additionally, based on the information provided in the Eddy County Soil Survey, the playa contains high amounts of clay, over 20 percent, and has a very low infiltration rate (Soil Survey Staff, Eddy County Soil Survey, 1981).

Wilson Playa also, does not have any known connection to interstate commerce. The playa is composed of siliceous soil material and does contain enough standing water for a long enough period of time to allow for game fowl to utilize the playa and be hunted.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
