The arroyos all discharge to uplands with the closest discharge to the Rio Grande**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

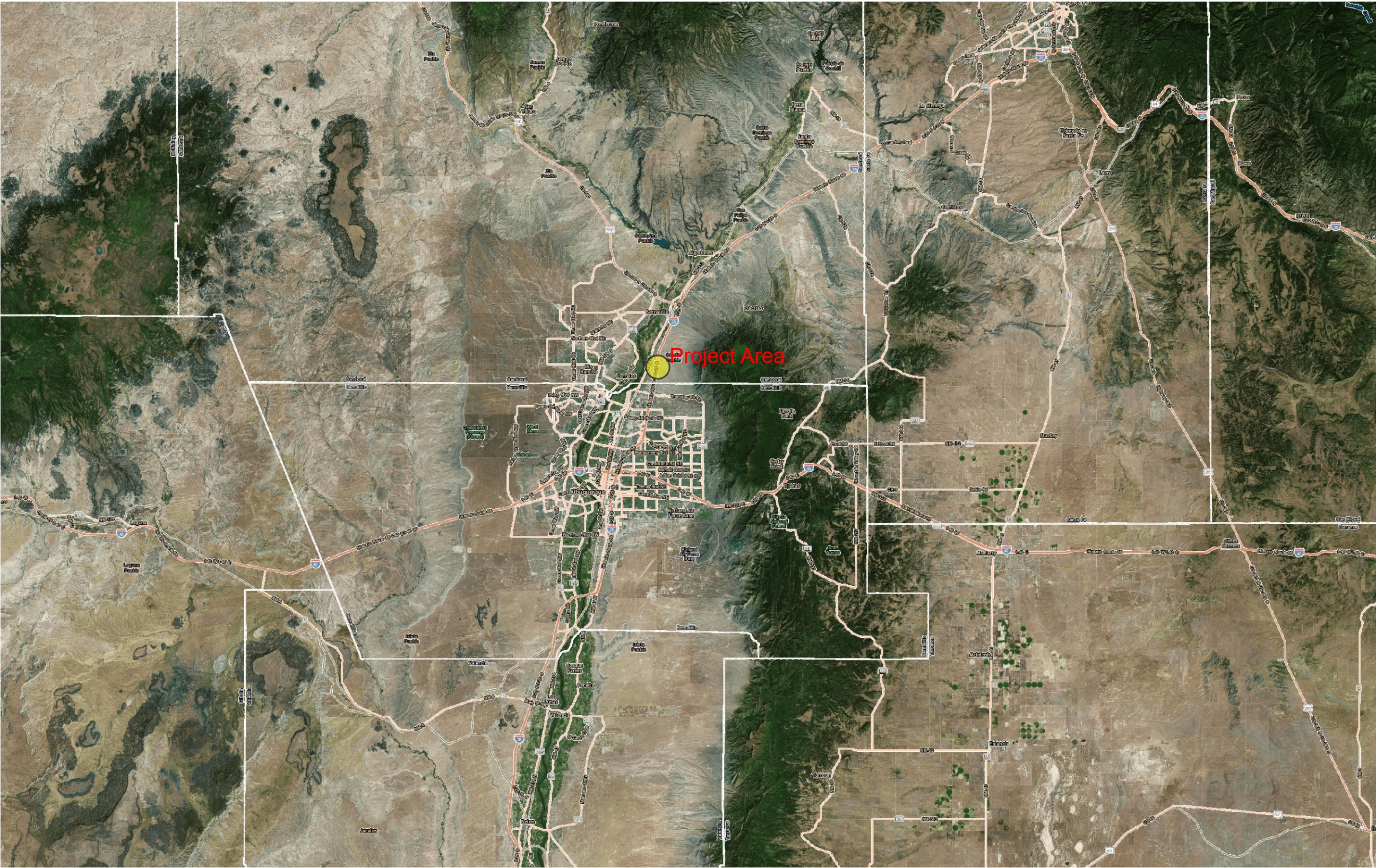
The Pueblo of Sandia has requested an approved jurisdictional determination for four ephemeral arroyo located within the Rio Grande-Albuquerque Hydrologica Unit Code (HUC). All four ephemeral arroyos included in this AJD originate on the western slope of the Sandia Mountains and convey flows during large storm events. They are located in an area that receives approximately 8.86 inches average annual rainfall and approximately 6.9 inches average annual snowfall. These drainages vary in width and exhibit discontinuous channel morphology along their respective alignments. They are primarily defined by landforms and flows are discrete, although some reaches do exhibit ordinary high water marks and evidence of flow. All four arroyos cross under Interstate 25 (I-25) in concrete -encased culverts. On the upstream side (east), the arroyos have been heavily modified by utility line and road construction. On the downstream side they have been significantly altered by heavy equipment during sediment removal.

The three northern arroyos converge into a single channel approximately 500 feet (ft) west of I-25. At this juncture the channel becomes poorly defined to non-existent and flows are spread across the landscape. The Pueblo Relief Road alignment located approximately 1,500 feet west of I-25 and small landforms north and south provide sheet flow barriers, pooling water at the culverted crossing. On the east side of this road alignment the channel becomes well-defined, deep (from 10 to 16 ft), wide (40 to 80 ft), and braided. Approximately 1,500 ft west of the Pueblo Relief Road, the drainage area has been altered by heavy equipment and channel morphology has been obscured. At the west end of this disturbed area is an improved surface road (South Santa Fe Trail), and an irrigation ditch parallels this road on its west side (dry at the time of the field assessment). In the instance of a very large storm event, flows at this point are channeled through a ditch crossing and down an access road, but no further evidence of the arroyo channel is present. As such, there is no physical surface connection between these three northern arroyos and the Rio Grande, which is over 0.3 miles to the west. The maps and photographs provided as attachments to this form support this determination.

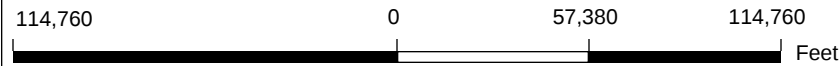
The southern arroyo has also been heavily modified on both sides of I-25. It exhibits similar characteristics as the northern arroyos, including the lack of channel morphology/sheet flow sections along its general trajectory. This arroyo also ends at its intersection with South Santa Fe Trail, approximately 0.36 miles from the Rio Grande. As such, there is no physical surface connection between the Subject Arroyo and the Rio Grande. The maps and photographs provided as attachments to this form support this determination.

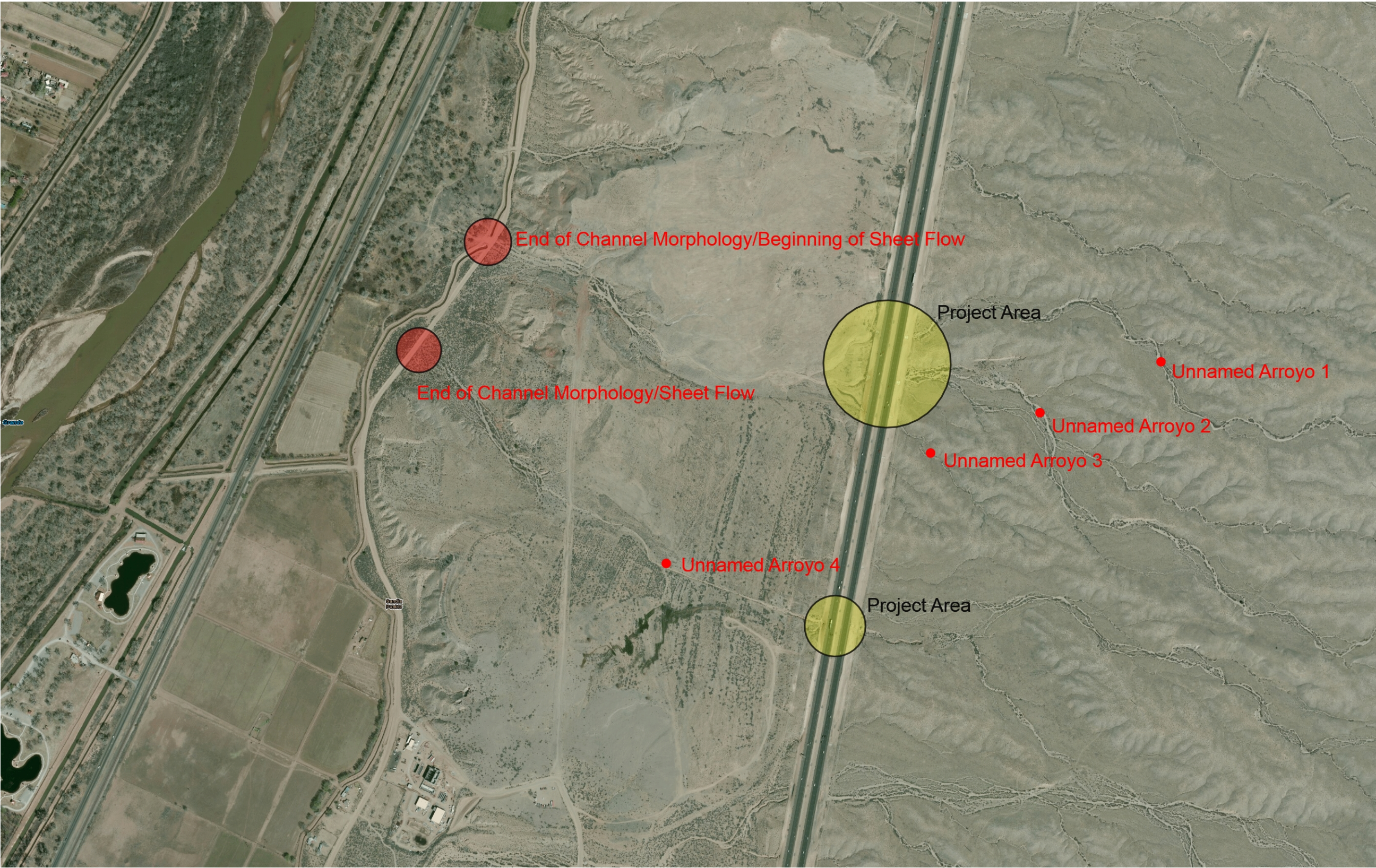
