This AJD considers three ephemeral arroyos in a 640 acre review area. They have been designated as Drainage A, Drainage B, and Drainage C. The drainages are located on Ceja Mesa approximately 5 miles west of Rio Rancho's

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Sandoval County has requested an AJD for three ephemeral arroyos in a 640 acre review area. They have been designated as Drainage A, Drainage B, and Drainage C. The drainages are located on Ceja Mesa approximately 5 miles west of Rio Rancho's city limits (see attached maps). These arroyos are determined to be isolated with no substantial nexus to interstate or foreign commerce.

Drainage A originates northwest of the review area and conveys storm flows within an approximate area of 1.17 square miles. It has a northwest-southeast orientation and flows into an unnamed arroyo beyond the review area before entering the Arroyo de las Calabacillas. Its northern extent is defined by a low gradient flow path with a robust vegetative community of grasses and cholla, with little indicators of a defined channel. Although short reaches of defined channel morphology are found, most of its extent does not possess an OHWM. Where defined channel segments do exist, they are small (average 2 feet width) and highly discontinuous.

Drainage B has an approximate drainage area of 0.48 square miles, whereas Drainage C sheds an approximate area of 0.14 square miles. Both drainages convey flows from major storm events (i.e. the 100-year storm) from the northwest uplands to an unnamed arroyo that eventually converges with the Arroyo de las Calabacillas. Drainage B extends for 3.23 miles from the review area before connecting to the Arroyo de las Calabacillas. Drainage C extends for 3.04 miles before reaching the same large ephemeral channel. Drainage B contains numerous reaches of various lengths that do not possess a defined channel (i.e. bed, banks, OHWM etc.) and Drainage C does not possess a defined channel anywhere within the review area. Overall, both features are defined by a low gradient flow path with a robust vegetative community of grasses and cholla (*Cylindropuntia imbricata*) and minimal defined channel morphology.

Based on the additional information provided below, the subject drainages do not possess more than a speculative or insubstantial effect on the physical, chemical and/or biological integrity of the Rio Grande, a TNW:

- It is highly unlikely that flows from major storm events within the review area reaches the Rio Grande given the distance (19.0 river miles), coupled with the flashy, infrequent, low-duration and low-volume nature of the subject drainages. Further, these drainages are highly discontinuous; as the majority of flow percolates into the ground in the numerous undefined reaches.

- The drainages do not provide habitat for species that occur within/along the Rio Grande. The Rio Grande and its floodplain are characterized as riparian habitat, with mature cottonwood (*Populus* spp.) galleries and poor- to well-developed understories. The subject drainages are characterized by the Arroyo Riparian vegetation type (Dick-Peddie 1993), dominated by tree cholla, one-seed juniper (*Juniperus monosperma*) and various grasses.

- Based on the size of the subject drainages, coupled with their distance from the Rio Grande, they do not provide lifecycle support for fish species. No aquatic organisms are present within the review area.

- The subject drainages do not transfer nutrients and organic carbons to the Rio Grande to support food webs.

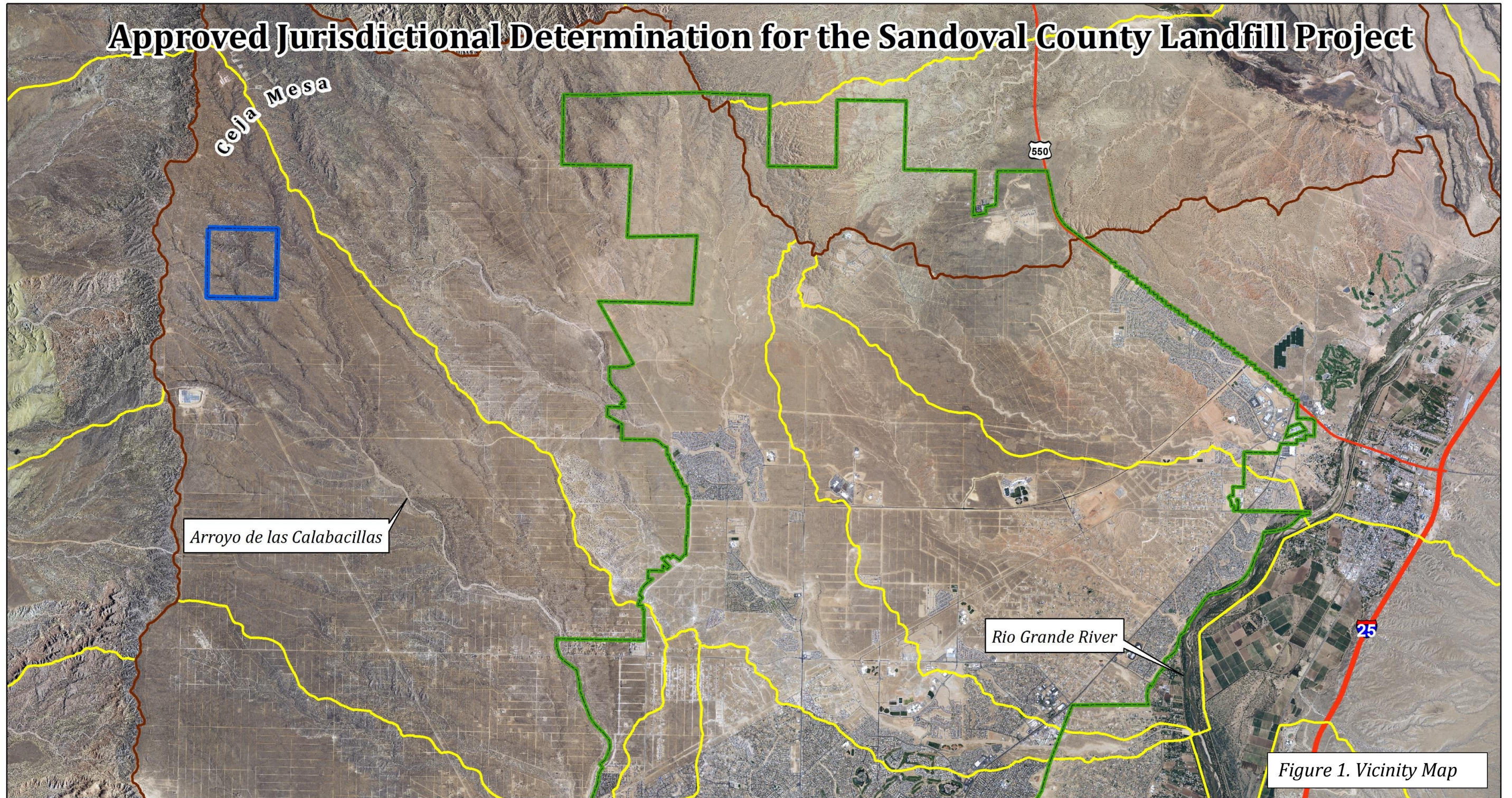


Figure 1. Vicinity Map

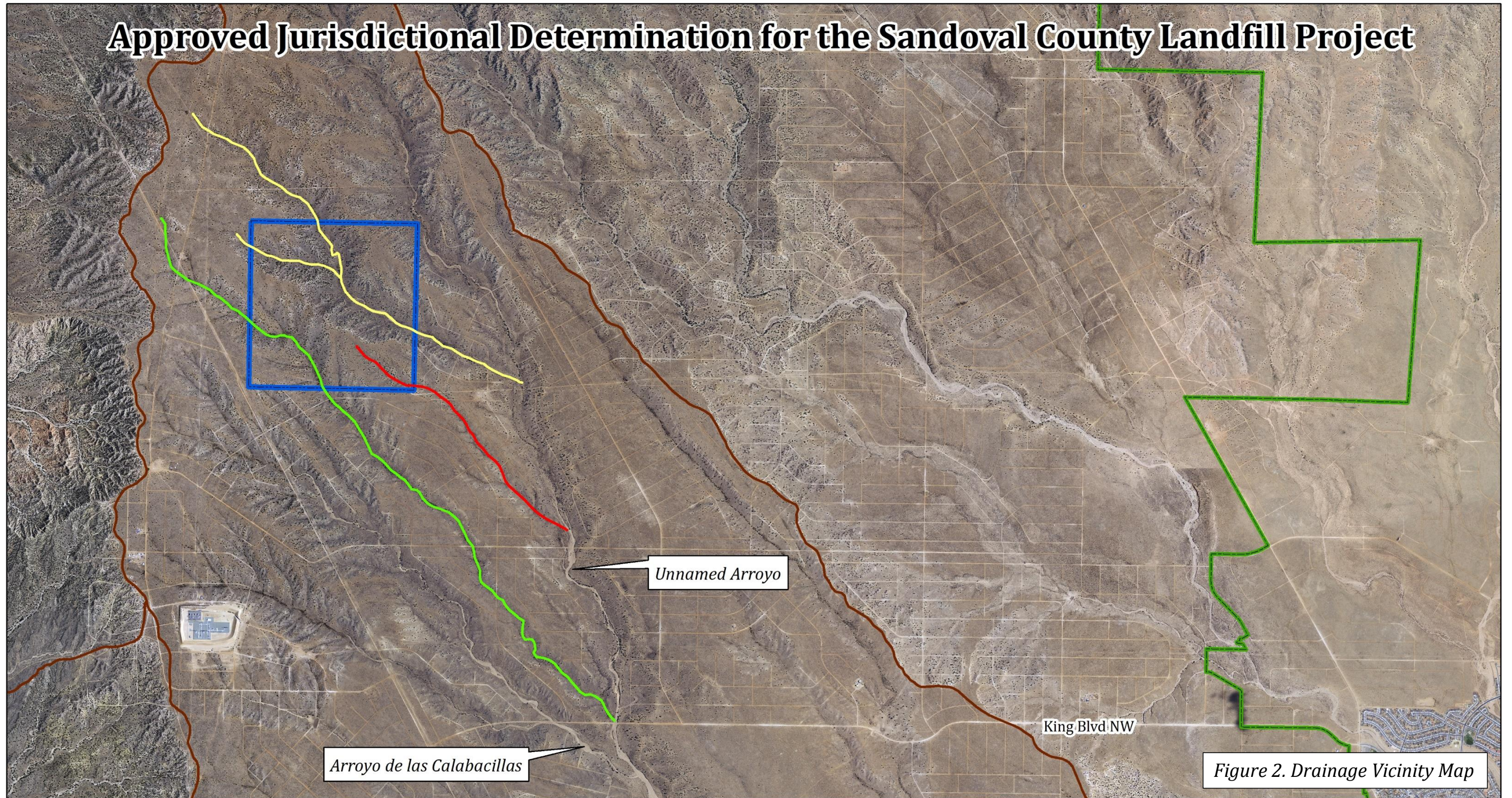


Figure 2. Drainage Vicinity Map

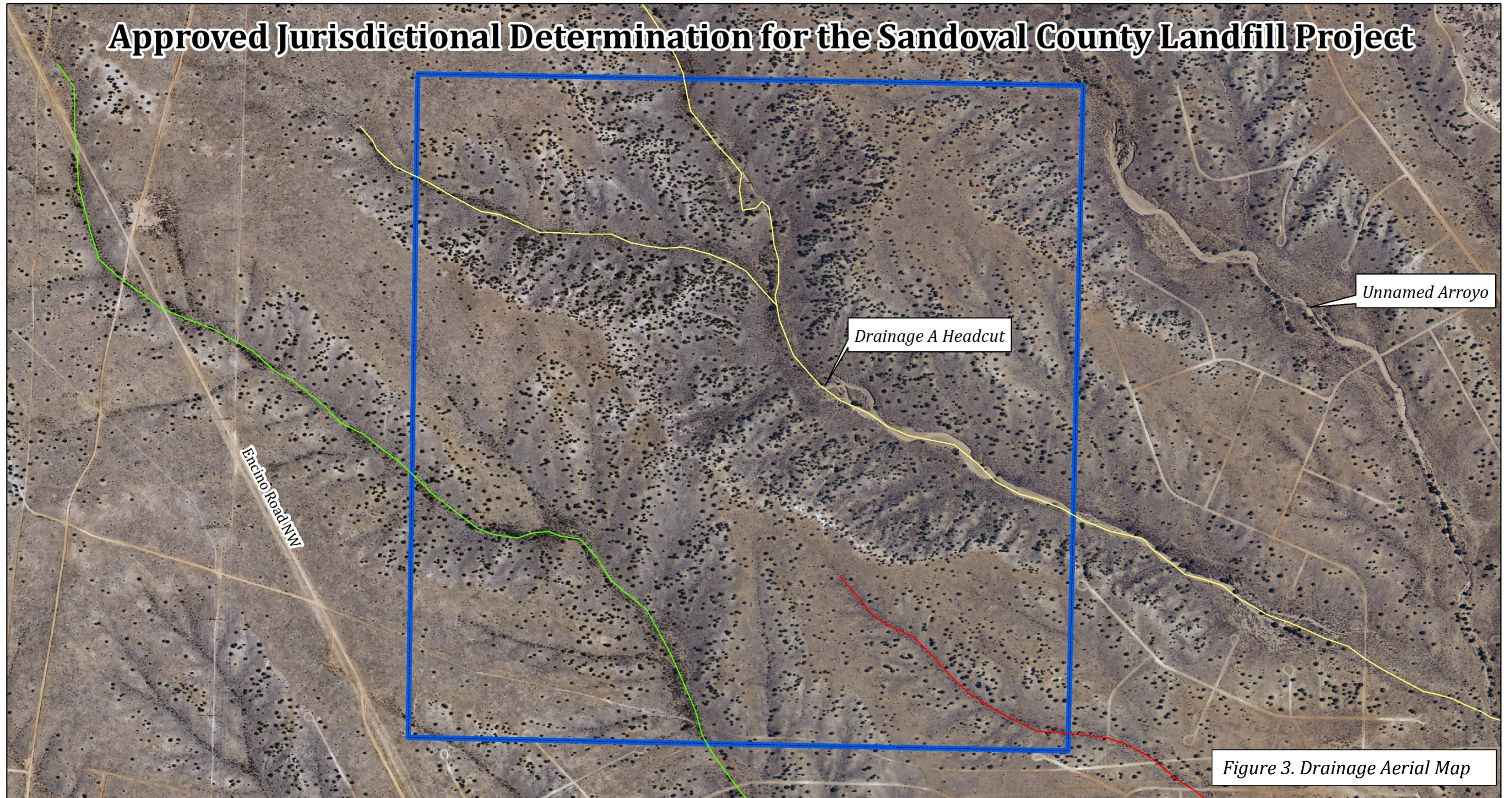


Figure 3. Drainage Aerial Map

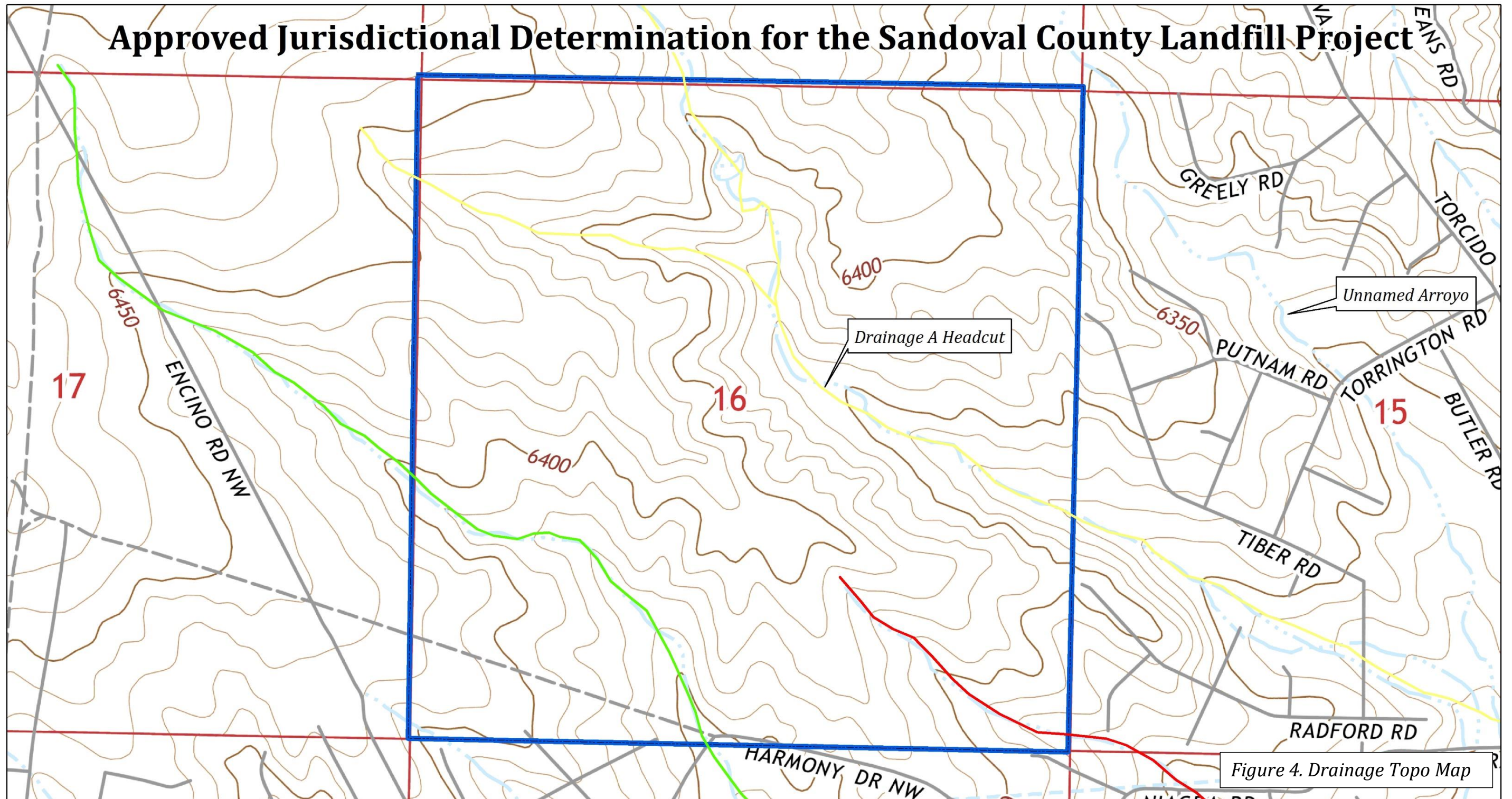


Figure 4. Drainage Topo Map

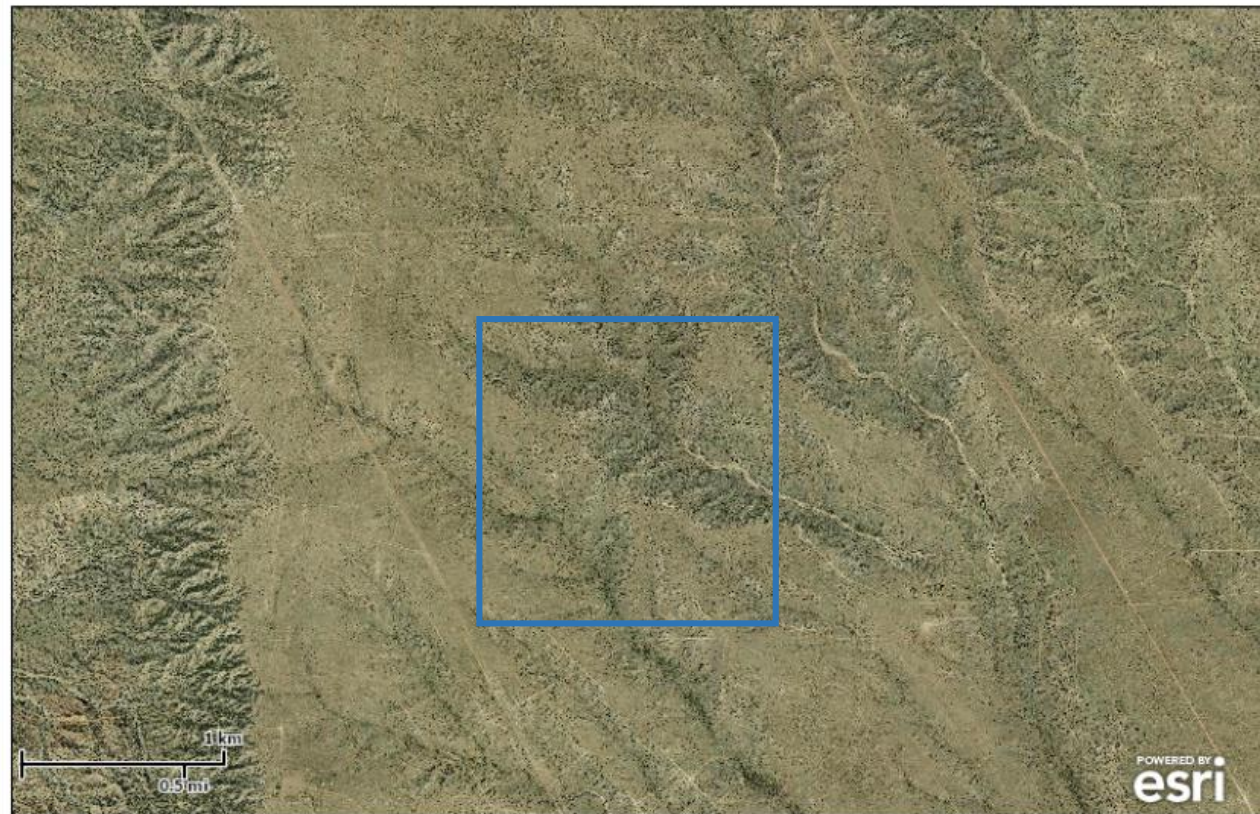
