Explain: **The subject property is approximately 412.73 acres (ac) dominated by native and non-native herbaceous and scrub-shrub vegetation. The property is currently being utilized as a facility that accepts oil exploration and production waste, excluding brine water and chlorides. The property is comprised of individual landfarm cells that are surrounded by containment berms with each cell divided by dirt roads. The property is previously disturbed from past ranching operations. The subject property contains 6 linear drainage features and 4 ponds. One of the linear drainage features is an unnamed ephemeral stream that contains an ordinary high water mark of approximately 15 feet (ft) wide on average and is approximately 4400 linear ft (lf) within the boundaries of the**

subject property. This feature is deeply incised between 10-18 ft deep and runs north to south, off the subject property where flows are captured in a depression created by a dirt road embankment and the embankments of upland constructed holding ponds. These off-site ponds and depressional area measure approximately 0.31 ac. Per communications with the current landowner, water has never flowed across the road since the road was constructed and water is pumped out of this depressional area into the adjacent ponds and used for providing water to local oil and gas operations. There is no outlet through the dirt road or adjacent ponds for flows in the unnamed ephemeral stream to continue downslope and into Canon de los Ojitos; an ephemeral stream located off-site to the southeast of the ponds and the nearest waterway to the unnamed ephemeral stream. The five other linear drainage features are vegetated across the channel and do not exhibit an ordinary high water mark; therefore, these features are characterized as swales. The swales all drain into the unnamed ephemeral stream described above. The swales measure approximately 17,100 lf in total within the boundaries of the subject property. There are 4 ponds located within the boundaries of the subject property; 2 ponds (one located west of the State Highway 537 and cell 14; and the other located just east of State Highway 537 and south of cell 3) were constructed entirely in uplands and measure approximately 0.18 ac and 0.07 ac; and 2 ponds were constructed on the linear drainage channels and capture flows from these channels, which measure approximately 0.34 ac and 0.44 ac. While these water features are associated with operation of a commercial facility, the commercial business does not support interstate commerce because the use of the facility only benefits local oil and gas operations. All of the water features described above are isolated, intrastate waters with no nexus to interstate commerce.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
