Explain: **The subject section of the Eastern New Mexico Rural Water System Project pipeline runs along the north side of U.S. 60 at the northwest corner of Cannon Air Force Base. Three small wetlands exist on the northern portion of U.S. 60. Wetland 1 is 0.02 acres, Wetland 2 is 0.07 acres, and Wetland 3 is 0.02 acres in size. The wetlands are associated with broken discharge pipes that discharge stormwater runoff from the Canon AFB golf course south of U.S. 60. The wetlands are dominated mostly by barnyard grass (Echinochloa crus-galli). The wetlands occur in a depressional area adjacent to a highway and south of a housing development. There are no**

channels or other outflows from the wetlands linking them to other waterways. All of the water features described above are isolated, intrastate waters with no nexus to interstate commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
