C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The New Mexico Abandoned Mine Land Program has requested a jurisdictional determination for an ephemeral arroyo located within the Puerco River Hydrologica Unit Code (HUC). The ephemeral arroyo included in this AJD originates within Allison and conveys flows during large storm events. It is located in an area that receives approximately 8 inches average annual rainfall and approximately 8 inches average annual snowfall. This drainage varies in width and exhibits discontinuous channel morphology along its respective alignment. It is primarily defined by landforms and flows are discrete, although some of its reach does exhibit ordinary high water marks and evidence of flow. The arroyo has been heavily modified by previous mining activities and road construction.

On the southern end of the channel, it becomes poorly defined to non-existent and flows are spread across the landscape. The drainage area has been altered by heavy equipment and channel morphology has been obscured. In the instance of a very large storm event, flows spread out onto an upland landscape, with no further evidence of the arroyo channel being present beyond the property boundaries. As such, there is no physical surface connection of this arroyo and the Puerco River, which is about 0.3 miles south. The maps and photographs provided as attachments to this form support this determination.
