This jurisdictional determination was requested by GRV Integrated Engineering Solutions LLC as part of the Saurey Subdivision. The area evaluated by the Corps pursuant to this jurisdictional determination request is the portion of the unnamed arroyo the crosses through the proposed development for 450 linear feet.

The unnamed arroyo that the commercial development will be constructed on, is an ephemeral arroyo that begins on site and flows from east to west for approximately 1,000 linear feet before entering the Bluff Channel System, a constructed concrete lined channel for 2.5 miles, before terminating within the Americas Basin System (The Basin). The basin is located

approximately 2,500 feet west of the intersection of IH-10 and Loop 375 in The City of El Paso, El Paso County, Texas (page 5, Delineation Report).

The basin which is the terminus point of the Bluff channel has a tributary area of 7.9 square miles and receives flow from concrete crest control inlets on the north and northeast sides of the dam. The inlet on the north side of the dam captures flow from Bluff Channel. The area of the basin is approximately 45 acres and it has a capacity of 960 acre-feet of storage. Americas Basin System is approximately 31 feet deep from the outer toe to the top of the embankment and has a perimeter of approximately 5,400 feet. The basin has an emergency spillway and a principal drop spillway, which is connected to a 36-inch diameter RCP. The basin was entered into HEC-HMS as a reservoir using the elevation storage function with the assumption that the basin is empty at the beginning of the storm event.” (El Paso Storm water Master Plan Volume I and II, March 2009).

The HEC-HMS (refer to attached computer models) determined that The Basin holds the 500-Year Design Storm of 536.6 acre-feet. (Graph 1, Delineation Report). The Basin has a capacity of 631 acre-feet before any water discharges the system.

The Rio Grande is the closest traditionally navigable water (TNW) to the unnamed arroyo and is located more than 4 miles from the arroyo and more than 2 miles away from The Basin. Between the arroyo’s terminus point and the river is agricultural land, residential and commercial development.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

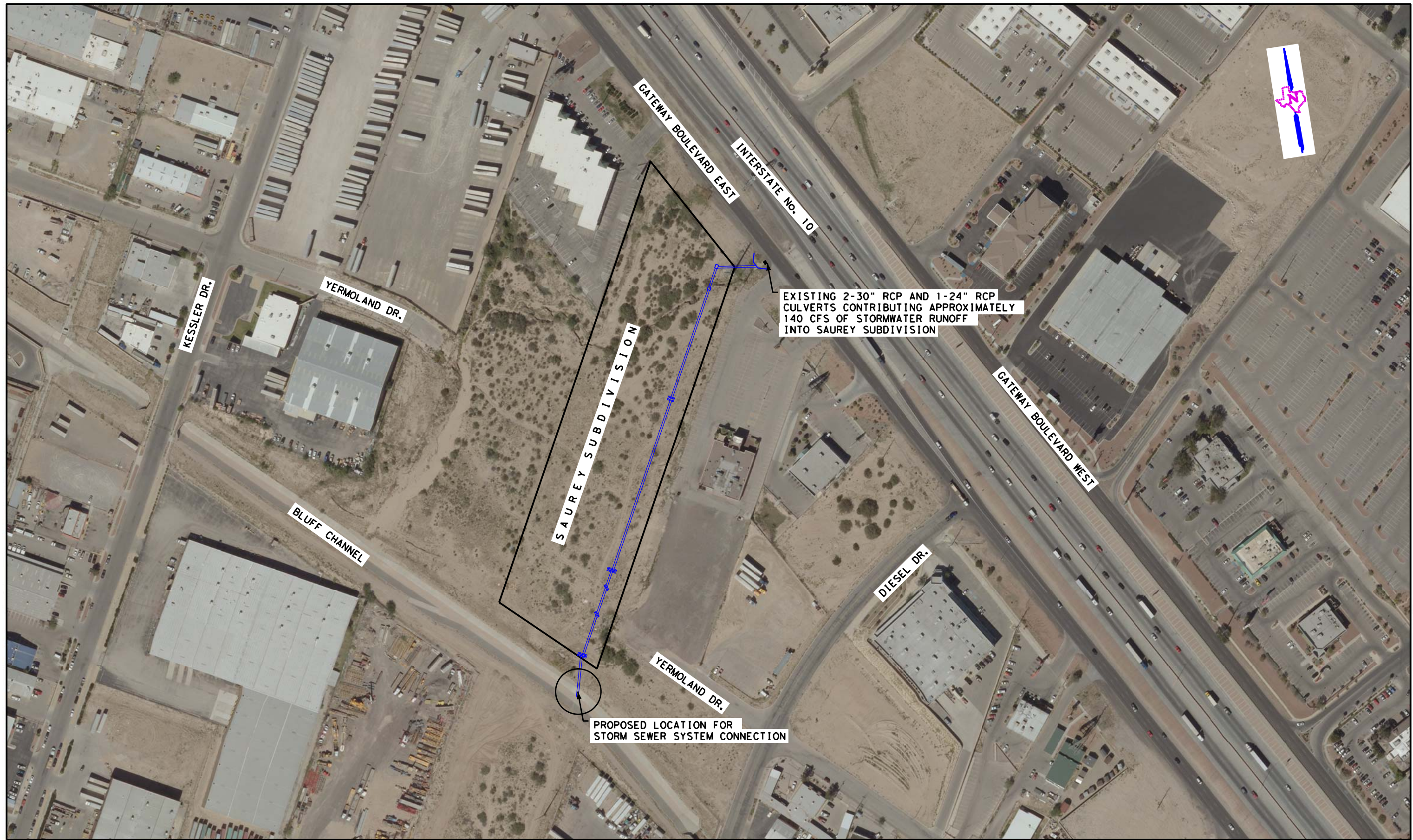

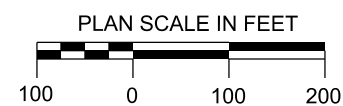

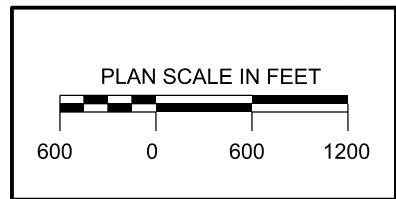
