C. Additional comments to support AJD: The review area is located approximately 2.5 miles west-northwest of the Nageezi Chapter of Navajo Nation within New Mexico. The applicant has provided a project map identifying the limits of where work would occur, and a site visit was conducted by a representative of the U.S. Army Corps of Engineers on April 24, 2020. The project area is located on land managed by the Bureau of Land Management, and the arid or semi-arid climate experiences low and highly variable precipitation that is driven primarily by convection during the wet months of July and August (EPA, 2008). Vegetation adjacent and within waterways in the area of review were identified using on-site photographs, aerial imagery, and Ordinary High Water Mark data sheets provided by the applicant and is predominantly sagebrush (*Artemisia tridentata*), rabbitbrush (*Ericameria nauseosa*), juniper (*Juniperus monosperma*), and unidentified upland grasses. Based on evaluated data, a site inspection, information provided by the applicant, and in accordance with 33 CFR 328.3 and the June 22, 2020 implementation of the Navigable Waters Protection Rule, drainages (DR) 9 and 10 do not meet the definition of "Waters of the United States" and are not subject to regulation under Section 404 of the Clean Water Act.




Figure E.1. NU H33 project area map.
