Explain: **Based on data from the U.S. Geological Service's (USGS) National Hydrograph Dataset (NHD), the agent for the requester identified four (4) potential aquatic resources (ARs) within the review area. These consist of three (3) watercourses and one (1) waterbody. The three watercourses do not exhibit a channel bed or bank. As such, these features are not jurisdictional. Additionally, the waterbody is a manmade stock pond constructed entirely within uplands. A berm on the western portion of the stock pond retains overland sheet flow from the east. No hydrophytic vegetation or hydric soils were observed around the periphery of the stock pond. Finally, it should be noted that no wetlands were identified within the survey area. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**& 26, 2020, the agent conducted a field assessment of the review area and documented the results within the report referenced above. During the fieldwork, the agent did not identify indicators of a channel bed or bank within the areas containing the USGS NHD flow lines. Photographs of these flow line locations provided by the applicant's consultant were utilized to verify the absence of channel bed and banks. A total of five (5) soil sample pits were excavated during the fieldwork, including at least one (1) pit within each flow line. Results yielded no hydric soils. The waterbody identified by the USGS' NHD is a manmade stock pond constructed entirely within uplands. A berm on the western portion of the stock pond retains overland sheet flow from the east. Furthermore, no hydrophytic vegetation or hydric soils were observed around the periphery of the stock pond.**

**Additional measures conducted as part of the AJD process included review of Google Earth and Digital Globe aerial imagery, which verified the findings from the fieldwork. Based on the information submitted in the delineation report and review of aerial imagery and on-site photographs, it has been determined that the review area does not contain any jurisdictional waters (i.e. Waters of the U.S.).**





Figure I Study Area
