- В. Typical year assessment(s): Data provided by USGS and NOAA indicates that this region is experiencing Extreme Hydrologic Drought and conditions are expected to persist.
- Additional comments to support AJD: The review area is located approximately 5 miles southeast of Blanco, New Mexico, and the applicant has provided a project map identifying the limits of where work would occur. The project area is located on land managed by the Bureau of Land Management,

and the arid or semi-arid climate experiences low and highly variable precipitation that is driven primarily by convection during the wet months of July and August (EPA, 2008). Vegetation adjacent and within waterways in the area of review were identified using on-site photographs, aerial imagery, and data sheets provided by the applicant and consists of sagebrush (*Artemisia tridentata*), greasewood (*Sarcobatus vermiculatus*), juniper (*Juniperus monosperma*), broom snakeweed (*Gutierrezia sarothrae*), rabbitbrush (*Ericameria nauseosa*), cheatgrass (*Bromus tectorum*), alkali sacaton (*Sporobolus airoides*), and Bailey's Narrow Leaf Yucca (*Yucca baileyi*). Based on evaluated data, information provided by the applicant, and in accordance with 33 CFR 328.3 and the June 22, 2020 implementation of the Navigable Waters Protection Rule, this reach of the unnamed tributary to Canon Largo does not meet the definition of "Waters of the United States" and is not subject to regulation under Section 404 of the Clean Water Act.
