C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The review area for this AJD consists of approximately 844-acres located City of Alamogordo in Otero County, New Mexico and encompasses the location of a proposed solar energy project by Solariant Energy Partners, LLC's (Solariant).

The review area is situated within the Western Great Plains Range and Irrigated Region Land Resource Region "G" as defined by the U.S. Department of Agriculture (USDA) and the Natural Resources Conservation Service (NRCS). More specifically, it falls within the Central New Mexico Highlands. The average annual precipitation for the region is between 11 to 15 inches of rainfall per year; and most of this precipitation occurs during the summer.

The dominant soils in the review area include Gypsum land, 9 to 35 percent slopes, (GyE); Alamogordo variant very fine sandy loam, 0 to 1 percent slopes (Aka); Alamogordo very fine sandy loam, 0 to 3 percent slopes (AbB); Ustic Torriorthents, frequent overflow, 0 to 1 percent slopes (UaA). The soil units discussed above are identified based on the area's taxonomic classification of dominant soils (USDA/NRCS, Web Soil Survey, 2019).

The nearest Traditionally Navigable Water (TNW) is the Rio Grande, which resides approximately 60 miles west of the review area. Flows are separated by the Organ Mountains, which creates a natural boundary between the Western Great Plains Range and Irrigated Region Land and the Western Range and Irrigated Region. This natural boundary disconnects the review area from the nearest TNW and its watershed.

The review area consists of uplands with an ephemeral stream channel indicated by the U.S. Fish and Wildlife Service's (USFWS) National Wetland Inventory map (NWI). Site photographs were provided along with satellite imagery showing that this stream channel does not exhibit a continuous ordinary high-water mark on its trajectory through the review area toward Raptor Lake. From Raptor Lake, a stream channel is present and oriented southwest toward Foster Lake; however, no evidence of flow between these two aquatic features was observed. Furthermore, Foster Lake is dry and has no outfall.

Based on the data provided by the consultant and information obtained by the Corps Regulatory Division personnel, the review area consists of dry land and isolated waters with no connection to interstate commerce. As such, the Corps has determined that there are no waters of the U.S. within the review area.
