### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The aquatic resource within the review area does not meet the definition of waters of the United States (WOTUS) pursuant to 33 CFR 328.3(a). It is a north-south oriented arroyo measuring 1500 feet (ft) in length that loses its

ordinary high-water mark at approximately latitude 35.522559° longitude -108.785608° and terminates into sheet flow approximately 800 ft from the Rio Puerco.

The review area has been heavily impacted since the late 1800s or early 1900s from underground coal mining, as well as from more recent construction and emergency response activities. As a result of these impacts—and based on vegetation and other observations—the arroyo does not appear to be in its original flow path and looks more like a maintained ditch. Based on a review of satellite imagery, the northern portion was clearly channelized sometime between October 23, 2011 and May 3, 2012; probably in association with the construction of an auto salvage yard (area marked as “fill pad” on the Site Overview Map). More recent channelization of this feature is also evident (see attached photos).

It should be noted that the Corps determined that this channel was non-jurisdictional in 2016 during review of an emergency action involving a discharge of fill material (Action Number 2016-332). The emergency action was conducted by the New Mexico Abandoned Mine Land Program in response to the appearance of several large sink holes within the channel—probably from the past underground mining activities.

It should also be noted that a wetland associated with stormwater ponds is located southeast of the review area and in proximity to Interstate 40. This wetland was not included in the review area because the proposed project for which this AJD was requested is designed to avoid impacting this aquatic resource.

The channelized arroyo within the review area does not have the capacity to support migratory birds or federally-listed species; or provide recreational opportunities. It is an isolated feature with no substantial nexus to interstate or foreign commerce and, therefore, does not meet the definition of a WOTUS.
