C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:





This jurisdictional determination was requested by the Acequia De Sombrillo in advance of their proposal to construct a sediment control pond located northeast of State Highway 106 off of County Road 90 near the town of Santa Cruz, Santa Fe County, New Mexico. The project area and review area (RA) are shown in Figure 1 (attached). The RA receives an average annual rainfall of 14 inches with an average annual winter snowpack of 0 inches. Based on statistical records the site receives an average daily rainfall of 0.3 inches during the monsoon season (July, August and September). This rainfall is usually due to short, intense storm events.

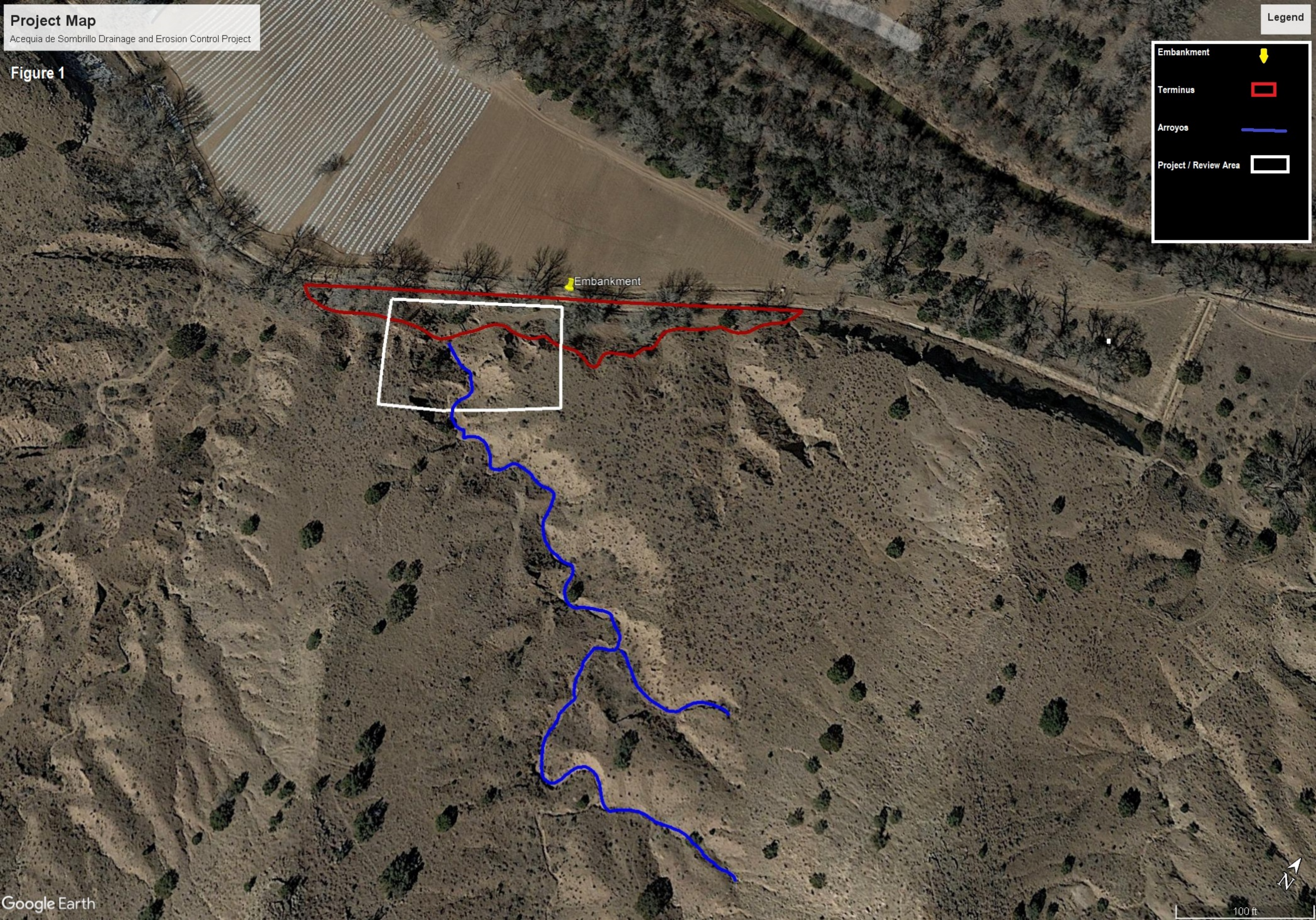
The RA contains an ephemeral stream channel that has a northwesterly gradient, with potential stormwater flows entering from the southeast. A small feeder channel connects to this arroyo at its southeastern end (Figure 1). These channels drain an area of less than 1 square mile. The stream channel within the RA terminates after approximately 750 linear feet and continues on as sheet flow toward an embankment constructed by local farmers to prevent sediment discharges and inundation of adjacent agricultural fields (Figure 1). A small discharge pipe extends through the constructed earthen embankment and drains to an adjacent concrete irrigation ditch (Picture 6). The irrigation ditch discharges into an adjacent agricultural field, and there is no return flow back to the San Cruz River.

The discharge pipe is installed at the top of the embankment, approximately 12 feet above ground level. Based on the width of the embankment and the height of the discharge pipe, the area behind the embankment will hold 209,136 cubic feet or 5-acre feet of water before discharging into the ditch. Therefore, runoff from an average monsoon season storm is detained by the embankment where it infiltrates without discharging to the fields below.

The Rio Grande is the closest traditionally navigable water (TNW) to the RA, and is located approximately 5 miles from where the stream channel terminates. As such, this arroyo does not have a substantial nexus to interstate commerce related to navigation, recreation, or other activities. Further, this feature does not contribute flows to a downstream RPW or TNW and, therefore, is isolated. As such, the RA does not contain waters of the United States.
