Explain: **The applicant has requested an approved jurisdictional determination (AJD) for four (4) ephemeral aquatic resources (AR) [i.e. Stream 1, Stream 2, Stream 3, & Stream 4] within the approximately 640-acre review area.**

Stream 2 is the confluence of Streams 1 & 3 and Stream 4 is a single AR with no upstream tributaries. Stream 2 and Stream 4 converge near the boundary of the review to form a single AR. On July 13, 2022, an onsite examination of

the ARs within the review area was conducted. A significant precipitation event occurred the day before the site visit which caused runoff within the western boundary of the site. Due to the remote setting of the review area, accurate rainfall data for the precipitation event was not able to be obtained. During the site visit heavy machinery was actively working within the review area, which included potential portions of Stream 4 and Stream 2. As a result of the heavy machinery work, the onsite examination was focused on the AR below the confluence of Stream 2 and Stream 4. The AR below this confluence did not contain streambanks, but gently sloping topography on each side of the area of flow. Within the AR were immature and mature vegetation throughout most of the course. A marginal ordinary high-water mark (OHWM) was visible starting at the confluence of Stream 2 and Stream 4 and continued a short distance downstream. The OHWM then became discontinuous and eventually transitioned into sheetflow with the area completely covered in upland vegetation (e.g. Sagebrush (*Artemisia* spp.), grasses (*Poaceae* spp.), and others). Sheetflow continued approximately 880-feet downstream until an approximately 1 to 2-foot wide marginal OHWM became present, which continued until it was bisected by a dirt road. Although stream flows were altered by the road, flows appeared to continue across the road. The AR across the road contained gently sloping banks, no clear OHWM, and immature and mature vegetation (e.g. Sagebrush [*Artemisia* spp.], grasses [*Poaceae* spp.], and others) throughout the channel. Further downstream, the OHWM is marginal and discontinuous, eventually transitioning to sheetflow with pockets of erosional features (i.e. features exhibiting some amount of runoff, but runoff does not occur at frequencies to create indicators of an OHWM or stream bed and banks). Based on the marginal to lack of OHWM throughout the stream course, the amount and type of vegetation growing within the AR, and the gently sloped banks, the confluence below Stream 4 and Stream 2 does not exhibit indicators that suggest it has the substantial capacity to contribute floodwaters into the San Juan River, a relatively permanent water (RPW) and tributary to the Colorado River, a traditional TNW, at periodic or continuous intervals. Therefore, Streams 1-4 do not have a significant effect on the chemical, physical, and biological integrity of the downstream traditional navigable waters and do not have a more than speculative significant nexus to a downstream TNW..

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

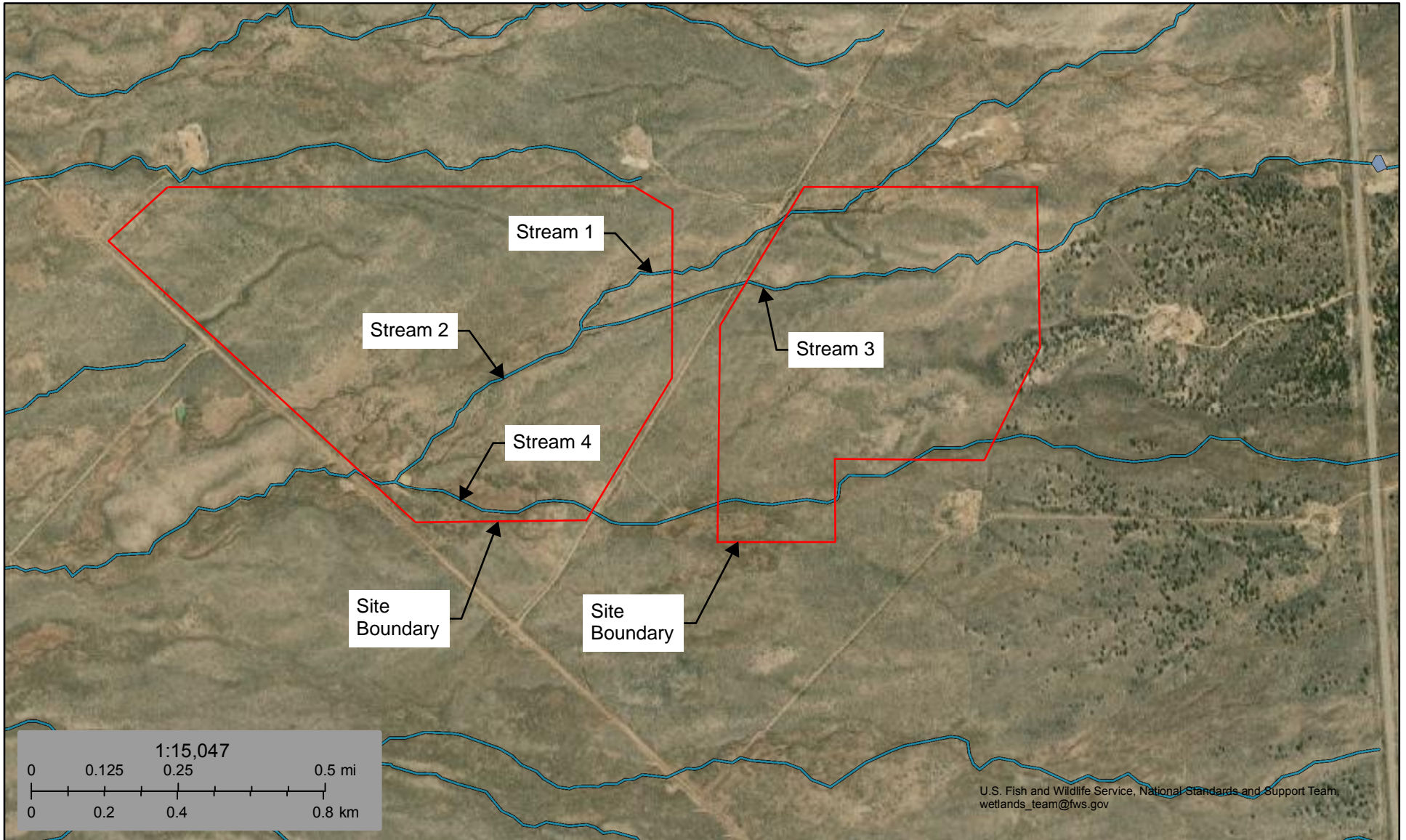

ADDITIONAL COMMENTS TO SUPPORT JD: Approximately 60 percent of the site is composed of Natural Resources Conservation Service (NRCS) defined ecological site description of Loamy (Ecological Site DX035X03E001) with 25 percent composed of the ecological site description of Clayey (Ecological Site DX035X03E004). Areas classified under the Loamy description typically contain level to gently sloping topography with slopes ranging from 1 to 8 percent. These areas are usually located on mesas, plateaus, and upland valleys at elevations between 5,000 to 7,000 feet above sea level. Soils within this ecological site description are typically moderately deep to deep, well drained with a water intake rate of medium to moderately rapid, and soil permeability class of slow to moderately rapid. Mean annual precipitation varies in this region type from 7 to 10 inches. Sites within the ecological site description of clayey are similar to loamy but with a few differences. Clayey sites typically contain slopes ranging from 0 to 3 percent, contain deep well-drained soils with water intake rate of moderate to moderately slow, and typically exhibit soil permeability class of moderately slow to moderate.
