B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:

Based on recent aerial imagery available and the data collected by the agent to support this AJD. The Study area (0.9 linear mile segment of the N2 Road) does not contain any drainage features and is comprised entirely of Uplands. Therefore, it has been determined that the 0.90-mile study area is comprised entirely of dryland and is not subject to jurisdiction under the CWA.
