**This jurisdictional determination was requested by the City of Las Cruces as part of its effort to construct a replacement sanitary sewer line along the top of Sand Hill Arroyo with occasional arroyo crossings to connect to existing sewer systems. The area evaluated by the Corps pursuant to this jurisdictional determination request is the portion of the Sand Hill Arroyo between the Los Colinas Subdivision and the arroyo's terminus point at El Camino Real Drive (See Maps 1 through 3).**

**This jurisdictional determination evaluation primarily relies on two reports submitted by the applicant – the Sand Hill Drainage Study, Drainage Report, June 2011 prepared by John Montoya (Drainage Report) and a Jurisdictional Determination**

Request prepared by Molzen Corbin dated May 7, 2013 (JD Request).

Sand Hill Arroyo is an ephemeral arroyo that begins at the Sand Hill Dam on the western slopes of the Jornada Basin in Dona Ana County. Sand Hill Arroyo flows from east to west through the north side of Las Cruces, New Mexico for approximately 4 miles, before terminating within a containment area at El Camino Real Drive. Sand Hill Arroyo is a broad sandy bottom channel dominated by upland vegetation (Photos Pg 24-28, JD Request). Sand Hill Dam (Chandler Tank) is regulated by the New Mexico Office of the State Engineer. This dam was constructed to control peak discharge to help reduce flooding. This dam is equipped with an emergency spillway which is approximately 275 feet wide and has concrete and rip-rap drops to dissipate energy from flows that pass over the spillway (pg 9 Drainage Report).

The Rio Grande is the closest traditionally navigable water (TNW) to the Sand Hill Arroyo and is located more than 2 miles from the arroyo's terminus point. Between the arroyo's terminus point and the river is agricultural land and residential development. The closest drain that would reach the Rio Grande is an agricultural drainage canal that is approximately .25 miles from the terminus point of Sand Hill Arroyo. (See map A).

The containment area located at the terminus point of the Sand Hill Arroyo is able to contain a 500 year storm event (Map 1, JD request). According to the Drainage Report, a 500 year storm event correlates to 3.93 inches of precipitation in 6 hours or 5.01 inches in 24 hours (Appendix C, Drainage Report). The 500 year storm event is modeled to be 1993.5 cfs (Table 4, Drainage Report). The mean annual precipitation for Las Cruces is 9 inches (pg 4, Drainage Report).

USACE visually investigated the containment area and observed no outlet points. The containment area's perimeter is lined with upland vegetation that has been established within copus dunes which gently slope toward the center of the containment area (Photos, pg 29, Delineation Report). Both the north and south sides of the containment area back up against agricultural fields that sit at an elevation below the vegetated copus dunes that enclose the containment area. The vegetated perimeter acts as a berm preventing water from moving out of the containment area. A storm event that exceeds the 500 year threshold could potentially fill up the containment area which would allow water to spill over the berms as sheet flow. The applicant has provided a response from the Federal Emergency Management Agency (FEMA) regarding the Drainage report. FEMA has accepted the applicant's findings and has incorporated them into its flood hazard analysis and associated maps.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
