Attached aerial photos of the site depict existing conditions. The dam's outlet is uncontrolled with discharge currently used to irrigate a multipurpose sports field. Residential development downstream of the dam site has obliterated surficial connectivity downstream of the multipurpose field. The dam outfall is located approximately 7.0 miles from the TNW Rio Grande. The dam and subsequent past development has resulted in the Arroyo de Domingo being an isolated water. There is no connection, and no significant nexus, between the arroyo and the TNW Rio Grande.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
