The stream in question is located within the Salt Basin, which is a closed basin. According to aerial photography, USGS topographic maps, and the NHD, the headwaters and terminus of the stream are entirely within the state of Texas. The nearest TNW is the Rio Grande, which is over 70 straight-line miles away. The nearest RPW that is a tributary to the Rio Grande is the Pecos River, which is over 50 miles away. The mountain ranges surrounding the basin create a watershed divide. There is no physical connection between this stream and any other aquatic resources outside of the Salt Basin. The primary hydrology source for the stream scud003 is presumed to be

local precipitation. No surface water or stream flow was observed during field survey. Based on the low annual precipitation rate and lack of connection to groundwater, it is presumed that scud003 does not have continuous flow for three months per year, and therefore is not considered to be a "relatively permanent water" (U.S. EPA, 2007). Aerial imagery, USGS topographic maps, NHD and NWI information support a conclusion that scud003 ultimately terminates in Salt Basin.

Given the stream measurements obtained during field surveys, and lack of consistent year round flow, we believe stream scud003 is non-navigable. The stream is not currently used, was not used in the past, and is not susceptible to use in interstate or foreign commerce. The stream is incapable of supporting transportation of commerce and is not accessible to the public. Lack of permanent flow and lack of connection to other relatively permanent water bodies indicates the stream cannot support fish or aquatic life. The land parcel the investigation area is located on is private property, and the nearest public road is Texas State Highway 54, approximately 12 miles west of the site. The property is owned and managed under a limited partnership. The parcel is not known to support public waterfowl hunting, commercial or recreational fishing, bird-watching, or any other form of water-related recreation. There is no evidence of public access to the stream, and no evidence to support use by out-of-state visitors for water-related commercial or recreational commercial activities. A review of the Audubon Society's database did not reveal any known Important Bird Areas on the property or within vicinity of the property. The nearest known Important Bird Area (IBA) is the Otero Mesa IBA over 40 miles from the investigation area in Otero County, New Mexico (National Audubon Society, 2013).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

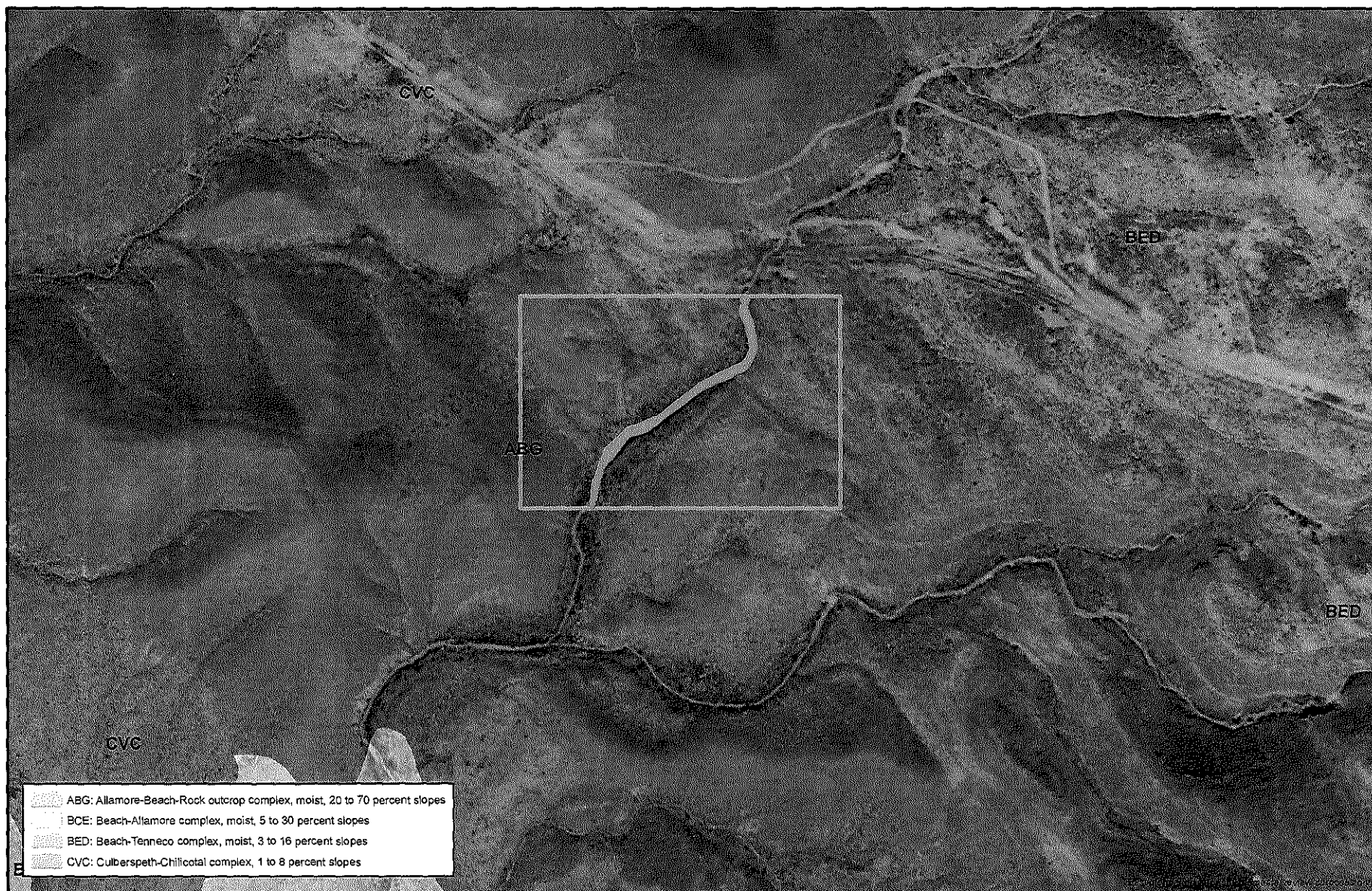
