## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The waters covered by this AJD include tributary 1 ( 3,345 lineat feet) and manmade ponds 1 thru 18 (1.1991 acres) ( IES, 2022). For the purpose of this jurisdictional determination (JD), these waters will collectively be referred to as RM 652 waters.

RM 652 waters are intrastate, ephemeral, isolated waters that have no connection to a Traditionally Navigable Water (TNW). The RM 652 waters also have no interstate commerce connection. The district’s evaluation is described in more detail below.

The Orla 7.5 minuet Quadrangle map is the collective area containing the RM 652 waters, it is a nearly level plain that is part of the Pecos River watershed, it is characterized by alkaline soils, upland vegetation, and nearly level slopes. It is a topographic plain with no external surface drainage (IES, 2022). The Pecos River is the nearest jurisdictional water body and is a tributary to the Rio Grande, which is a traditionally navigable water (TNW). The confluence of the Pecos River and the Rio Grande is approximately 200 miles downstream from the review area.

Surface water in the RM 652 waters is ephemeral. Surface waters from Tributary 1 drain to the surrounding man-made ponds, that terminate within the ponds and have no surface outlet. The Pecos River is approximately 5 miles southwest of RM 652 waters. However, all surface water flow terminates at within the manmade ponds never reaching the Pecos River (IES, 2022).

Based on Cooperative Climatological Station data, the average annual precipitation is 12.88 inches for the period 1986 to 2014. The climate is arid to semi-arid, and the majority of the precipitation falls during the summer monsoon season. The monsoon rains are typically characterized as high intensity, short duration, isolated thunderstorms. Evaporation is high, nearly 8 times the amount of annual precipitation.

According to the Federal Emergency Management Agency (FEMA) Flood Insurance Rate Map (FIRM), the RM 652 waters are unmapped therefor fall outside of the 100-year floodplain of the Pecos River (IES, 2022).

The dominant soils in the review area include the Cottonwood, and Reeves Soil Series. The Cottonwood and Reeves series are medium-textured to moderately fine-textured Aridisols formed in residuum weathered from gypsum. These soils are slightly saline to strongly saline with high gypsum and calcium carbonate concentrations in the soil profiles. The soils in the review area are generally not mapped as hydric soils and therefore cannot be considered jurisdictional wetlands (USDA NRCS 2016).

The RM 652 waters do not have a connection to a TNW. As discussed above, there is no physical connection between the RM 652 waters and the Pecos River which flows to the Rio Grande, the closest TNW. Likewise, there is no biological or chemical connection. Evaporation is the dominant form of water loss from the waters and there is limited ground water recharge. No fish or amphibious species are known to inhabit the ponds.

Since the RM 652 waters are all ephemeral in nature there is no form of navigation to contribute to interstate commerce, also no other form of interstate commerce regardless of navigation is known to occur.
